

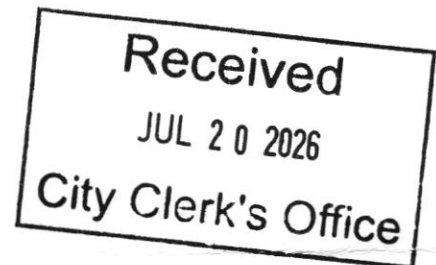

ORDINANCE NO. 26-015 - AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF FORT PIERCE, FLORIDA; AMENDING CHAPTER 103 - BUILDINGS AND BUILDING REGULATIONS, ARTICLE III - CONTRACTORS, BY AMENDING SECTION 103-89 BY MODIFYING THE APPOINTMENT PROCEDURES OF MEMBERS TO THE BOARD OF EXAMINERS OF CONTRACTORS; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.
