Pinewood Park had no electricity and leaks at one of the pavilions. The Maravilla Park had multiple issues in the restrooms, no yellow visual aide stripe around the benches, the trees needed trimming, the playground equipment was dirty, and the need for a sidewalk from the handicap parking lot to the building. They mentioned how nice the dog park was at Maravilla Park. The Public Works Director, Jason Atkinson, let the board know the restrooms throughout all the parks need refurbishment.

b. Pioneer Park Plaque Program Update

Ms. Commond gave an update on the Pioneer Park Plaque Program. She let them know the program needs updated guidelines, more public and church involvement, and they would possibly need to narrow the number of plaques from 16 to a smaller number. This project will also need a project manager. The Board would like to request the City Manager to find the funds for this project as it has been held up for a few years now.
