ORDINANCE NO. 7179

AN ORDINANCE CANVASSING THE RESULTS OF A GENERAL ELECTION FOR THE PURPOSE OF ELECTING COUNCILMEMBERS TO DISTRICTS 1, 2, 4, and 5 OF THE CITY OF GARLAND, TEXAS AND FOR THE PURPOSE OF SUBMITTING TO THE VOTERS A PROPOSITION REGARDING THE USE OF A PORTION OF HOLLABAUGH PARK AS A LIBRARY FOR AN ELECTION HAVING BEEN HELD ON NOVEMBER 3, 2020; DECLARING THE RESULTS OF THAT ELECTION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on the 17th of November, 2020, such date being within the time prescribed by law for the canvassing of election results at an election called by a municipality, the City Council canvassed the results of the general election for the purpose of electing Councilmembers to Districts 1, 2, 4, and 5 of the City of Garland, Texas and for the purpose of submitting to the voters a proposition regarding the use of a portion of Hollabaugh Park as a library for an election having been held on the 3rd of December, 2020; such election having been duly ordered by the City Council under the authority of the Constitution and laws of the State; and

WHEREAS, the City Council has determined that the election officials of the voting districts of the City have, in compliance with the law, made returns to the City Council in the time and manner required; and the City Council having canvassed the votes from each of those districts does find the total number of votes cast for each candidate was as follows:

Section 1

That, having canvassed the results of the election, the City Council determines that the following candidates were elected to the following positions and are hereby declared elected to office, subject to the taking of the oath of office as prescribed by the Texas Constitution:

Section 2

That, having canvassed the results of the election, the City Council further determines that the following proposition was approved by the voters:

Proposition A

Shall the City Council be authorized, as otherwise limited by and pursuant to State law, to approve the construction and use of a library facility within a portion of public property designated as parkland, commonly known as Hollabaugh Park.

Section 3

That the Councilmember and sole candidate for Councilmember for District 1, previous to the election, announced his resignation from the City Council therefore creating a vacancy in District 1 to be filled in accordance with the applicable provisions of the City Charter and the Texas Election Code.

Section 4

That this Ordinance shall become effective immediately upon and after its passage and approval.
