#### PUBLIC COMMENTS ON WORK SESSION ITEMS

Members of the audience may address the City Council on any Work Session item at the beginning of the meeting. Speakers are allowed three minutes each, grouped by agenda item and called in the order of the agenda. Anyone wishing to speak must fill out a speaker card (located at the entrance to the Council Chambers and on the visitor's side of the Work Session Room) and give it to the City Secretary before the Mayor calls the meeting to order. Speakers are limited to addressing items on the Work Session agenda only. Items on a Regular Meeting agenda should be addressed at the respective Regular Meeting. - 4. Personnel matters involving the appointment, employment, evaluation, reassignment, duties, discipline or dismissalof a public officer or employee or to hear a complaint against an officer or employee. Sec. 551.074, Tex. Gov't Code.
- 5. The deployment, or specific occasions for implementation of security personnel or devices. Sec. 551.076, Tex. Gov't Code.
- 6. Discussions or deliberations regarding commercial or financial information that the City has received from a business prospect that the City seeks to have to locate, stay, or expand in or near the territory of the City and with which the City is conducting economic development negotiations; or to deliberate the offer of a financial or other incentive to a business prospect of the sort described in this provision. - 7. Discussions, deliberations, votes, or other final action on matters related to the City's competitive activity, including information that would, if disclosed, give advantage to competitors or prospective competitors and is reasonably related to one or more of the following categories of information:
  - generation unit specific and portfolio fixed and variable costs, including forecasts of those costs, capital improvement plans for generation units, and generation unit operating characteristics and outage scheduling;
  - bidding and pricing information for purchased power, generation, and fuel, and Electric Reliability Council of Texas bids, prices, offers, and related services and strategies;
  - effective fuel and purchased power agreements and fuel transportation arrangements and contracts;
  - risk management information, contracts, and strategies, including fuel hedging and storage;
  - plans, studies, proposals, and analyses for system improvements, additions, or sales, other than transmission and distribution system improvements inside the service area for which the public power utility is the sole certificated retail provider; and
  - customer billing, contract, and usage information, electric power pricing information, system load characteristics, and electric power marketing analyses and strategies. Sec. 551.086; Tex. Gov't Code; Sec. 552.133, Tex. Gov't Code]

#### Issue/Summary

Following the completion of significant public improvements in the downtown district, strategic redevelopment efforts are now focused on underutilized city-owned properties within it. A balance between modernization, historical character, and timely execution are key concerns in this initiative while striving to stimulate economic growth. This agenda item introduces a suggested project plan to solicit proposals from a successful master developer for the revitalization of *519 W. State Street*, *713 Austin Street*, *316 N. Glenbrook Avenue*, *415 W. Avenue A*, *116 S. Sixth Street*, *703 W. Avenue A*, and *717 W. Avenue A*.

#### Background

Historically, the downtown district has been central to the city's cultural and economic life. Yet, with time, certain city-owned properties within this area have not realized their full potential, affecting the district's vibrancy and economic output. The strategy to redevelop these properties has been shaped to include external expertise and community engagement to ensure a balanced and forward-looking approach.

#### **Consideration / Recommendation**

Staff is seeking Council's endorsement to proceed with this approach, ensuring redevelopment efforts are aligned with community vision.





#### Issue/Summary

Ceason Clemons, PE, Dallas District Engineer will provide City Council with a status update on the IH635 East reconstruction project.

#### Background

The segment of IH635 East, spanning from US75 to IH30, was originally constructed in the 1960's as an eight-lane freeway without frontage roads. Subsequently, only a managed lane has been incorporated into the infrastructure. The initiative to procure funding from the state legislature and administration for the Texas Department of Transportation (TxDOT) to overhaul this thoroughfare into a ten-lane modern freeway equipped with a managed lane and comprehensive continuous frontage roads was spearheaded by the City of Garland, in collaboration with the City of Dallas and the Regional Transportation Council. Starting in 2020, TxDOT, in conjunction with the design-build contractor PLC, embarked on the reconstruction of IH635. It is anticipated that this project will be completed in 2026. Periodic updates regarding the progress of IH635 have been provided by TxDOT representatives, with the most recent being during the April 17, 2023, work session. Throughout 2024, significant traffic shifts are expected as underground utilities and drainage structures along the corridor's periphery are finalized, while the primary construction activity moves to the center. Concurrently, increased activity will be observed at cross streets as construction efforts in these areas pick up.

Ceason Clemons was appointed as the Dallas District Engineer in November 2022 and has been with TxDOT since 2005.

#### Consideration / Recommendation
