

RESOLUTION NO. R21-19

A RESOLUTION OF THE COUNCIL OF THE CITY OF GLENDALE, MARICOPA COUNTY, ARIZONA, APPROVING AND AUTHORIZING SUBMISSION OF THE SUBSTANTIAL AMENDMENT 1 TO THE 2016-17, 2017-18, 2018-19 AND 2019-20 ANNUAL ACTION PLANS TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT IN THE COMBINED AMOUNT OF \$456,381.93.

WHEREAS, in accordance with the federal regulations found at 24 CFR 91, the City of Glendale is required to submit a Five-Year Consolidated Plan and five (5) Annual Action Plans to the U. S. Department of Housing and Urban Development ("HUD") for its Community Development Block Grant ("CDBG"), and Emergency Solutions Grants ("ESG") funding;

WHEREAS, modifications to either the Consolidated Plan or the Annual Action Plans that exceed thresholds in 24 CFR 91 necessitate the completion and submission of a Substantial Plan Amendment.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLENDALE as follows:
