

RESOLUTION NO. R21-20

A RESOLUTION OF THE COUNCIL OF THE CITY OF GLENDALE, MARICOPA COUNTY, ARIZONA, APPROVING AND AUTHORIZING SUBMISSION OF THE SUBSTANTIAL AMENDMENT 1 TO THE FY 2020-21 ANNUAL ACTION PLAN TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT AND ACCEPTANCE OF AN AWARD OF \$2,044,841 OF COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS AND \$2,997,188 OF EMERGENCY SOLUTIONS GRANT PROGRAM FUNDS PROVIDED THROUGH THE CARES ACT.

WHEREAS, the City was awarded \$2,044,841 in Community Development Block Grant funds (CDBG-CV3) and \$2,997,188 in Emergency Solutions Grant Program (ESG-CV2) through the CARES Act and passed through the US Department of Housing and Urban Development; and

WHEREAS, these funds must be incorporated into the City's 2020-21 Annual Action Plan allocated to eligible activities pursuant HUD regulations and provisions of the CARES Act;

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLENDALE as follows:
