

AMENDMENT NO. 1  
INTERGOVERNMENTAL AGREEMENT  
(Services of School Resource Officers, Contract No. C18-0719)

This Amendment No. 1 (“Amendment”) to the Agreement for Services of School Resource Officers (“Agreement”) is made this \_\_\_\_\_ day of \_\_\_\_\_, 2021, (“Effective Date”), by and between the City of Glendale, an Arizona municipal corporation (“City”) and Glendale Union High School District, political subdivision of the State of Arizona (“Contractor”).

RECITALS

- A. City and Glendale Union High School District (“Contractor”) previously entered into an Agreement for Services of School Resource Officers, Contract No. C18-0719, dated August 21, 2018 (“Agreement”); and
- B. The Agreement had an initial one-year term beginning August 6, 2018 through May 22, 2019 and provided the option to be extended for up to three (3) additional school years in one-year terms; and
- C. City and Contractor entered into a contract extension, C18-0719-1, for the school year beginning August 5, 2019 and ending May 20, 2020; and
- D. City and Contractor entered into a contract extension, C18-0719-2, for the school year beginning August 10, 2020 and ending May 26, 2021; and
- E. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.

AGREEMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

- 1. **Recitals.** The recitals set forth above are not merely recitals but form an integral part of this Amendment.
- 2. **Term.** The term of the Agreement is extended for an additional school year, from August 9, 2021 through May 25, 2022, unless otherwise terminated or canceled as provided by the Agreement. All other provisions of the Agreement except as set forth in this Amendment shall remain in their entirety.
- 3. **Removal of Party to the Agreement.** The Agreement shall be amended to remove Glendale High School, 6216 West Glendale Avenue, Glendale, Arizona 85301, as a “Party” to this agreement. All references to Glendale High School are stricken from the agreement.

4. **Compensation.** The cost reflected in Section 4 of the Agreement remains unchanged.
5. **Non-discrimination.** Contractor must not discriminate against any employee or applicant for employment on the basis of race, color, religion, sex, national origin, age, marital status, sexual orientation, gender identity or expression, genetic characteristics, familial status, U.S. military veteran status or any disability. Contractor will require any Sub-contractor to be bound to the same requirements as stated within this section. Contractor, and on behalf of any subcontractors, warrants compliance with this section.
6. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.
