

AMENDMENT NO. 1  
JOB ORDER CONTRACTING FOR FENCING  
(City of Glendale, Contract No. C22-0197)

This Amendment No. 1 (“Amendment”) to the Job Order Contracting for Fencing (“Agreement”) is made this \_\_\_\_\_ day of \_\_\_\_\_, 2022, (“Effective Date”), by and between the City of Glendale, an Arizona municipal corporation (“City”) and AA Anchor Fence., Inc., dba Associated Fence, an Arizona corporation authorized to do business in Arizona (“Contractor”).

RECITALS

- A. On February 22, 2022, the City and Associated Fence of Glendale, LLC (“Contractor”) entered into Linking Agreement, Contract No. C22-0197, (“Agreement”); and
- B. The original Mohave County Contract, Contract No. AFCCO-1103 had an initial one-year term beginning November 3, 2020, through November 3, 2021 and provided the option to extend for an additional four (4) years renewable on an annual basis; and
- C. On January 3, 2022, Contractor filed a Trade Name application with the Arizona Secretary of State to conduct business as Associated Fence. A similar certification documenting AA Anchor Fence, Inc. dba Associated Fence was filed with the Internal Revenue Service on April 4, 2022; and
- D. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.

AGREEMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

- 1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
- 2. **Term.** The term of the Agreement is unchanged.
- 3. **Scope of Work.** The Scope of Work is being amended to make this a Citywide use contract identified in the Scope of Work attached as Exhibit B.
- 4. **Compensation.** The compensation for this Agreement is being increased by \$400,000 for a new not-to-exceed amount of \$1,200,000.
- 5. **Insurance Certificate.** Current certificate expired on October 1, 2022. A new certificate applying to the extended term must be provided to Materials Management

and the Contract Administrator, as a condition precedent to this Amendment taking effect. If a new insurance certificate is not provided within 30 days of the execution of this Amendment, this Agreement shall become null and void

6. **Non-discrimination.** Contractor must not discriminate against any employee or applicant for employment on the basis of race, color, religion, sex, national origin, age, marital status, sexual orientation, gender identity or expression, genetic characteristics, familial status, U.S. military veteran status or any disability. Contractor will require any Sub-contractor to be bound to the same requirements as stated within this section. Contractor, and on behalf of any subcontractors, warrants compliance with this section.
7. **No Boycott of Israel.** To the extent A.R.S § 35-393 through § 35-393.03 are applicable, the parties hereby certify that they are not currently engaged in, and agree for the duration of the Agreement to not engage in, a boycott of goods or services from Israel, as that term is defined in A.R.S § 35-393.
8. **Attestation of PCI Compliance.** When applicable, the Contractor will provide the City annually with a Payment Card Industry Data Security Standard (PCI DSS) attestation of compliance certificate signed by an officer of Contractor with oversight responsibility.
9. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.


