

RESOLUTION NO. R24-78

A RESOLUTION OF THE COUNCIL OF THE CITY OF GLENDALE, MARICOPA COUNTY, ARIZONA, DECLARING THE OFFICIAL CANVASS OF VOTES CAST IN THE CITY OF GLENDALE PRIMARY ELECTION HELD JULY 30, 2024; DECLARING THE ELECTION OF THREE COUNCIL MEMBERS; AND ORDERING THAT A CERTIFIED COPY OF THE RESOLUTION BE RECORDED.

WHEREAS, the City of Glendale held a Primary Election Tuesday, July 30, 2024, for the purpose of electing persons to the office of Mayor and Council Members in the Cactus, Sahuaro and Yucca Districts; and

WHEREAS, A.R.S. § 16-642 requires that the City Council canvass the returns of the election not less than six (6) days nor more than twenty (20) days following the election; and

WHEREAS, the City Council having canvassed the returns of the July 30, 2024 Primary Election, finds the returns to be as stated in this resolution.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLENDALE as follows:

SECTION 1. That the total number of ballots rejected was 121 (Exhibit A).

SECTION 2. That the total number of votes cast at said Primary Election, as shown by the Precinct Canvass report was 31,653 (Exhibit B).

SECTION 3. That the votes cast for the candidates for Mayor and Councilmember were as follows:
