

RESOLUTION NO. R24-134

A RESOLUTION OF THE COUNCIL OF THE CITY OF GLENDALE, MARICOPA COUNTY, ARIZONA, TO AMEND THE COUNCIL MEETING RULES AND PROCEDURES TO MOVE THE CITIZEN COMMENTS TO A SEPARATE LISTENING SESSION AFTER THE ADJOURNMENT OF THE REGULAR COUNCIL VOTING MEETINGS.
