

RESOLUTION NO. R25-53

A RESOLUTION OF THE COUNCIL OF THE CITY OF GLENDALE, MARICOPA COUNTY, ARIZONA, AUTHORIZING AND DIRECTING THE ENTERING INTO AMENDMENT NO. TWO (25-0011050-1) TO THE INTERGOVERNMENTAL AGREEMENT (IGA 21-0008103-1) WITH THE ARIZONA DEPARTMENT OF TRANSPORTATION FOR THE CONSTRUCTION OF SIDEWALKS AND RELATED WORK.

WHEREAS, on April 23, 2024, City Council previously approved Amendment No. 1 of an Intergovernmental Agreement with the Arizona Department of Transportation (IGA 21-0008103- 1) (C21-0338-1) for the design and construction of sidewalks and related work in the area bounded by Palmaire Avenue, 46th Avenue, Bethany Home Road, and Grand Avenue; ("Project"); and

WHEREAS, the Federal Government approved funds through the Federal Highway Administration ("FHWA") agency to Glendale to improve sidewalk connectivity and address substandard pedestrian facilities in the Project area; and

WHEREAS, the Federal Highway Administration (FHWA) is responsible for 94.3% of the Project .and the City will be responsible for 5.7% of the Project; and

WHEREAS, the City of Glendale and the Arizona Department of Transportation wish to further amend said Intergovernmental Agreement, increasing the project cost by \$1,197,605, for a new project budget of \$4,267,850.00, which includes federal aid and the City's match.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLENDALE as follows:

SECTION 1. That it is deemed in the best interest of the City of Glendale and the citizens thereof to enter into Amendment No. One to the Intergovernmental Agreement with the Arizona Department of Transportation for the design and construction of sidewalks and related work in the area bounded by Palmaire Avenue, 46th Avenue, Bethany Home Road, and Grand Avenue (IGA 21-0008103-1), which agreement is now on file in the office of the City Clerk of the City of Glendale.

SECTION 2. That the City Manager or designee and City Clerk are authorized and directed to execute and deliver any and all documents necessary to effectuate said Agreement on behalf of the City of Glendale.
