SAID PARCEL CONTAINS 1,735,989 SQUARE FEET OR 39.8528 ACRES, MORE OR LESS.

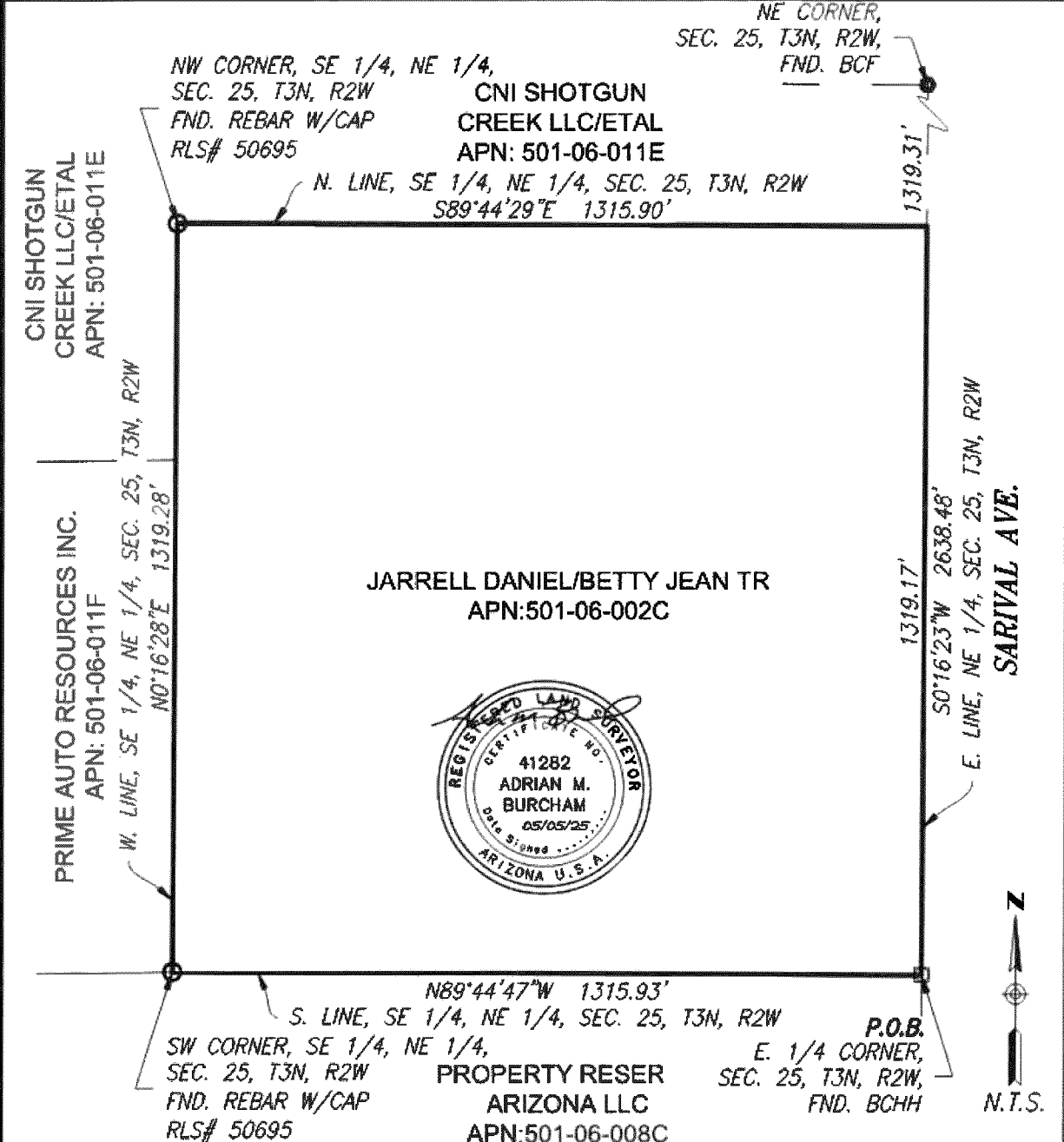
