The previous ownership of the establishment, identified as Karen Wilson, held a Series 6 (Bar) liquor license. That license is currently inactive and is not in use within the City of Glendale.

Prior Incident at Location under Previous Ownership (Karen Wilson):

On 05/04/2025 at approximately 1946 hours, an incident occurred at 6729 N 57th Dr in which three subjects were shot and pronounced deceased on scene. This incident was investigated and classified as a homicide by the Glendale Police Department.

At the time of the incident, the establishment operating at that location was known as El Camaron Gigante Mariscos & Steakhouse. That business has since permanently closed and is no longer in operation in the City of Glendale.

The prior ownership of El Camaron Gigante Mariscos & Steakhouse has no involvement and/or affiliation with the current applicant, Hector Alonso Trujillo.

No special concerns were found at this time under new ownership with the new applicant.
