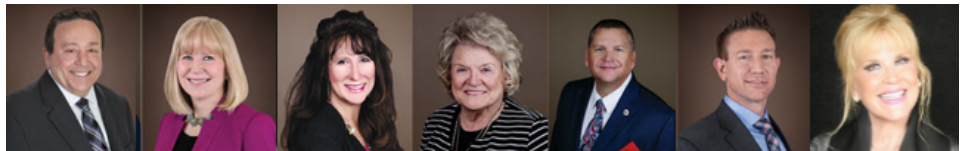
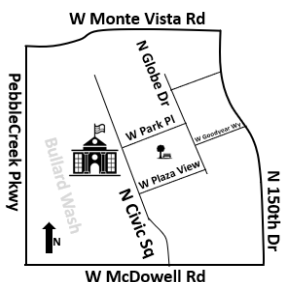

Planning Manager Steve Careccia presented information on the request for a use permit for a convenience use (drive-through) for Ono Hawaiian BBQ restaurant. He outlined the ingress and egress of traffic through the 1-acre parcel within the Canyon Trails Towne Center located on the northeast corner of Yuma Road and Cotton Lane.

Mayor Pizzillo closed the public hearing at 7:00 p.m.

Council inquired on the drive-through and expressed concern that it would not be sufficient to keep cars from blocking or backing up traffic. Mr. Careccia said that the traffic study supported the placement of the drive-through.

10. **ZONING ORDINANCE TEXT AMENDMENT TO AMEND THE CITY'S LANDSCAPE STANDARDS**

Planning Manager Steve Careccia reviewed the changes in the Landscape standard, including the number of trees required in a specific area and the limits now put on turf.

Mayor Pizzillo closed the public hearing at 7:20 p.m.

Council asked questions about future development for recreation use such as a golf course, or soccer fields. Mr. Careccia responded that uses like that would likely need a Planned Area Development where waivers to standards could be evaluated by staff and sent through the governing bodies.

Interim Deputy City Manager Paul Luizzi presented information on the Automatic Aid agreement. He spoke about the agreement beginning in 1976 with Goodyear joining in 1999. He outlined the obligations of the parties listed in the agreement.

Council spoke about the provisions of the automatic aid agreement that said if a party annexes area outside their service area that they will create and distribute a plan to the other parties. Council stated that the city of Glendale has annexed area up to and past the Loop 303 without making any plans to service the area. Council asked that staff approach the Life Safety Council to develop an alternative governance mechanism and not just Fire Chiefs that oversee the agreements. Council also asked that letters be sent to the Council members in the City of Glendale outlining the issues.

MOTION BY Councilmember Bill Stipp, SECONDED BY Councilmember Patrick Bray to APPROVE and authorize the City Manager or designee to enter into a new Intergovernmental Agreement ("IGA") between the City of Goodyear and the City of Phoenix to provide and receive automatic assistance for fires and other types of emergency incidents. It was further noted that the approval of the agreement was under protest with the current conditions in place involving the City of Glendale. The motion carried as follows:

**SUBJECT: INTERGOVERNMENTAL AGREEMENT (IGA) WITH THE CITY OF PHOENIX
FOR THE ADMINISTRATION OF THE DEPARTMENT OF JUSTICE
EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT (JAG)**

STAFF PRESENTER(S): Santiago Rodriguez, Chief of Police

SUMMARY

The City of Phoenix is administering the Edward Byrne JAG funding on behalf of Maricopa County.

Recommendation

Approve the IGA with the City of Phoenix for grant administration for the Edward Byrne Justice Assistance Grant. (Santiago Rodriguez, Chief of Police)

FISCAL IMPACT

The DOJ Edward Byrne Memorial JAG program is funded by the Department of Justice and managed by the Bureau of Justice Assistance. The grant award for FY2023 is \$14,425, with no matching fund requirement from the City of Goodyear.

BACKGROUND AND PREVIOUS ACTIONS

The Bureau of Justice Assistance (BJA) is responsible for managing the Edward Byrne Memorial JAG program for the Department of Justice. Until 2021, the city of Goodyear had received a direct award from BJA for this grant. The BJA required that if the grant awarded to the county and multiple municipalities within that county are eligible for direct awards that exceed 400% of the county's total award amount, the county must administer the grant. The City of Phoenix has been designated as the administration entity for Maricopa County for the FY2023 awards. This agreement allocates 10% of our DOJ grant allocation (\$15,828) to the City of Phoenix for administration functions that it will perform on behalf of Goodyear. The total funding amount for FY2023 will be \$14,245. The City of Phoenix is requiring an IGA with the City of Goodyear in order to administer the Edward Byrne JAG program.

STAFF ANALYSIS

The IGA with the City of Phoenix allows the Goodyear Police Department to utilize the DOJ Edward Byrne JAG program award allocation of \$14,245 to provide breeching equipment for each of our patrol sergeants. The Office of the Chief has weighed the benefits of adding the additional breeching equipment to each patrol sergeant's vehicle and accepts the City of Phoenix's 10% administration fee.

RECITALS

WHEREAS, the PARTIES have become entitled to certain grant funds through the Edward Byrne Memorial Justice Assistance Grant (JAG) Program; and

WHEREAS, a disparity exists between the funding eligibility of the PARTIES as determined by 42 USC § 3755 (d)(3)(4); and

WHEREAS, Federal law requires that units of local government within a group of jurisdictions identified as disparate to agree upon an allocation process; and

WHEREAS, the PARTIES believe it to be in their best interests to reallocate the JAG funds to resolve said disparity.

NOW THEREFORE, in consideration of the foregoing recitals, which are incorporated herein by reference, the following mutual covenants and conditions, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the PARTIES hereby agree as follows:

SECTION 1

The purpose of this AGREEMENT is to reallocate the funds available to the PARTIES from the Edward Byrne Memorial Justice Assistance Grant (JAG) Program and to resolve disparities in compliance with 42 USC § 3755 (d)(3)(4). In compliance therewith the PARTIES agree PHOENIX shall receive all the funds and distribute the funds to AVONDALE, BUCKEYE, CHANDLER, GILBERT, GLENDALE, GOODYEAR, COUNTY, MESA, PEORIA, SCOTTSDALE, SURPRISE, AND TEMPE as follows:

1. PHOENIX agrees to receive **\$1,609,591** from the JAG award for the PHOENIX JAG Program; and
2. PHOENIX agrees to pay AVONDALE a total of **\$21,021** of JAG funds; and
3. PHOENIX agrees to pay BUCKEYE a total of **\$9,356** of the JAG funds; and

4. PHOENIX agrees to pay CHANDLER a total of **\$43,233** of JAG funds; and

7. PHOENIX agrees to pay GOODYEAR a total of **\$14,245** of JAG funds; and
8. PHOENIX agrees to pay COUNTY a total of **\$38,766** of JAG funds; and
9. PHOENIX agrees to pay MESA a total of **\$143,150** of JAG funds; and
10. PHOENIX agrees to pay PEORIA a total of **\$31,420** of JAG funds; and
11. PHOENIX agrees to pay SCOTTSDALE a total of **\$32,437** of JAG funds; and
12. PHOENIX agrees to pay SURPRISE a total of **\$12,731** of JAG funds; and
13. PHOENIX agrees to pay TEMPE a total of **\$72,022** of JAG funds; and
14. PHOENIX shall retain **\$1,093,104** for the JAG Program (collectively “allocated funds”).
15. PHOENIX agrees to make all payments to AVONDALE, BUCKEYE, CHANDLER, GILBERT, GLENDALE, GOODYEAR, COUNTY, MESA, PEORIA, SCOTTSDALE, SURPRISE, AND TEMPE within thirty (30) days after receipt of the JAG funds by PHOENIX.

SECTION 2

The PARTIES agree to use allocated funds for the JAG Program on or before September 30, 2025.

SECTION 3

1. **Term.** The term of this AGREEMENT shall commence simultaneously with the FY2022 JAG grant program year on October 1, 2021 and continue until September 30, 2025 unless terminated sooner in accordance with the terms of the grant, and such reasonable time thereafter as may be needed to complete the administration of the grant.
 - A. **Obligations of PHOENIX.** PHOENIX agrees to administer the Funds as provided in Section 1, and shall:

- (a) Agree that PHOENIX will administer the Funds as provided in Section 1; and
- (b) Will maintain and provide to PHOENIX all financial and program reports as required by the terms and conditions of the grant and applicable Federal regulations; and
- (c) Will be responsible for the actions of their respective employees in providing services under this AGREEMENT and shall hold harmless the PARTIES to this AGREEMENT from any liability that may arise from the furnishing of the services by the other PARTIES.

2. DISCLAIMER. This AGREEMENT is not intended to and will not constitute, create, give rise to, or otherwise recognize a joint venture, agency, partnership or formal business association or organization of any kind among the PARTIES, and the rights and obligations of the PARTIES shall be only those expressly set forth in this AGREEMENT.

3. NON-AVAILABILITY OF FUNDS. Each payment obligation of the PARTIES created hereby is conditioned on the availability of funds. The PARTIES recognize that the continuation of this AGREEMENT after the close of any of their respective fiscal years shall be subject to the approval of their respective governing bodies providing an appropriation covering this item as an expenditure. None of the PARTIES represent that said budget items will be actually adopted.

SECTION 4

The PARTIES to this AGREEMENT do not intend for any third party to obtain a right by virtue of this AGREEMENT.

SECTION 5

Notice is given that pursuant to A.R.S. 38-511 the PARTIES may cancel any AGREEMENT without penalty or further obligation within three years after execution of the AGREEMENT, if any person significantly involved in initiating, negotiating, securing, drafting or creating the AGREEMENT on behalf of the PARTY is at any time while the AGREEMENT or any extension of the AGREEMENT is in effect, an employee or agent of any other party to the AGREEMENT in any capacity or consultant to any other party of the AGREEMENT with respect to the subject matter of the AGREEMENT. Additionally, pursuant to A.R.S. 38-511 the PARTIES may recoup any fee or commission paid or due to any person significantly involved in initiating, negotiating,

SECTION 9

SUBJECT: AMERICAN RESCUE PLAN ACT PASS-THROUGH GRANT APPLICATION TO MARICOPA COUNTY

SUMMARY

Council consideration and possible authorization for staff to submit an application to Maricopa County for federal American Rescue Plan Act (ARPA) funds for the Suncrest Vista senior housing development.

Recommendation

ADOPT RESOLUTION NO. 2023-2287, AUTHORIZING THE SUBMISSION OF AN APPLICATION FOR AMERICAN RESCUE PLAN ACT (ARPA) PASS-THROUGH FUNDS TO THE MARICOPA COUNTY HUMAN SERVICES DEPARTMENT, AUTHORIZING THE CITY MANAGER OR HER DESIGNEE TO EXECUTE ALL DOCUMENTS RELATING TO SAID APPLICATION, AND AUTHORIZING THE CITY MANAGER OR HER DESIGNEE TO NEGOTIATE THE TERMS OF AN INTERGOVERNMENTAL AGREEMENT WITH MARICOPA COUNTY AND AN AGREEMENT WITH DOMINIUM, INC. (IF GRANT FUNDS ARE AWARDED). (Jenna Goad, Assistant to the City Manager)

FISCAL IMPACT

There is no local match required, however, if grant funds are awarded there will be administrative expenses associated with ongoing compliance and reporting. It is unknown if these costs can be offset by a portion of the grant funding. The estimated cost of the Suncrest Vista development is \$110,785,135 and the grant application would be for an amount not to exceed \$4.0 million.

BACKGROUND AND PREVIOUS ACTIONS

The Maricopa County Board of Supervisors has approved an additional allocation of \$65 million in American Rescue Plan Act (ARPA) 2021 State and Local Fiscal Recovery Funds for affordable housing development. The Maricopa County Human Services Department is looking to support affordable housing development projects that are in need of additional funding in cooperation with local jurisdictions who can demonstrate strong partnerships and the leveraging of local funding or assets.

Council approved a request to rezone approximately 29 acres generally located southeast of Cotton Lane and Van Buren Street for the Suncrest Vista and Estrella Springs multi-family housing developments on January 24, 2022.

STAFF ANALYSIS

If funds are awarded, the City will enter into an Intergovernmental Agreement with Maricopa County in order to receive the funds. The terms of that IGA are not yet known. The City would also need to enter into an agreement with the developer, Dominion, Inc., to specify the terms of the funding pass-through. The City will likely be responsible for the ongoing monitoring and reporting associated with the use of federal ARPA funds, which may be for a period of 20 years or more. The City would also need to ensure compliance with any additional terms specified in the agreement with Dominion, Inc. If selected for award, the City Manager, or her designee, will negotiate the terms of both agreements and bring them to City Council for approval.

FISCAL IMPACT

INTRODUCTION

The purpose of this document is to define the City of Goodyear's legislative priorities and core values for the 2023 federal and state legislative sessions. This serves as the leading document to provide direction to Government Relations staff to ensure the City is actively engaging on issues at the U.S. and State Capitols that reflect the priorities and mission of the Goodyear City Council.

CORE VALUES

Maintain Goodyear's High Quality of Life

Protect those attributes that make Goodyear a desirable community for families and businesses alike. These may include: open space; economic prosperity; safe neighborhoods; efficient transportation; public safety; and managed growth.

Preserve Local Funding

Protect existing funding sources that bring revenue to the City of Goodyear, which support the quality of life for its residents. The most common examples of this are the portion of state shared income tax (urban revenue sharing), state transaction privilege tax, residential rental and food taxes, and Highway User Revenue Fund monies cities receive from the state. Any efforts to reduce, sweep or eliminate any of these shared revenue sources will be opposed.

Oppose Preemption of Local Authority

Support local decision-making authority. The City of Goodyear was created by its residents through incorporation in 1946 - the community entrusts their local elected officials to protect public health, safety and quality of life. Any efforts to weaken or eliminate local control and decision-making authority through preemption or mandates will be opposed.

Protect the Mission of Luke Air Force Base

Sustain the long-term mission and viability of Luke Air Force Base through local and regional community support as well as any state or federal legislation that strengthens local efforts to protect the base. Specific items may include: protecting military airports, limiting encroachment, and expanding future missions.

Promote Economic Development & Prosperity

Maintain and enhance the caliber of economic development opportunities available to the City through supporting new and existing tools for private sector growth and revitalization. Support legislative changes that allow growth to pay for itself in order to attract new and reliable development opportunities.

Collaborate to Build a Robust Transportation Network

Engage regional partners and collaborate to ensure Goodyear's residents have reliable and efficient transportation options in and out of their community. Support legislation to prepare for the possible extension of the voter-approved Proposition 400 sales tax for transportation. Encourage efforts that modernize existing funding sources to ensure viability and maintenance of the transportation network.

Support federal and state funding for statewide, regional and local transportation and infrastructure projects. Work collaboratively with our federal, state, regional, and other local delegations to secure grant funding for the region's important infrastructure needs.

Protect & Enhance Water Supply

Collaborate with the Arizona Municipal Water Users Association to support legislation that encourages practical water efficiency and conservation measures. Protect surface water and uphold the principles of the Groundwater Management Act. Ensure the City of Goodyear is able to supply assured, safe and sustainable water to its residents.

Phoenix-Goodyear Airport

Continue to partner with the City of Phoenix (Arizona) to ensure continued operations of the Phoenix-Goodyear Airport. Monitor and be aware of changes to made by the Federal Aviation Administration.

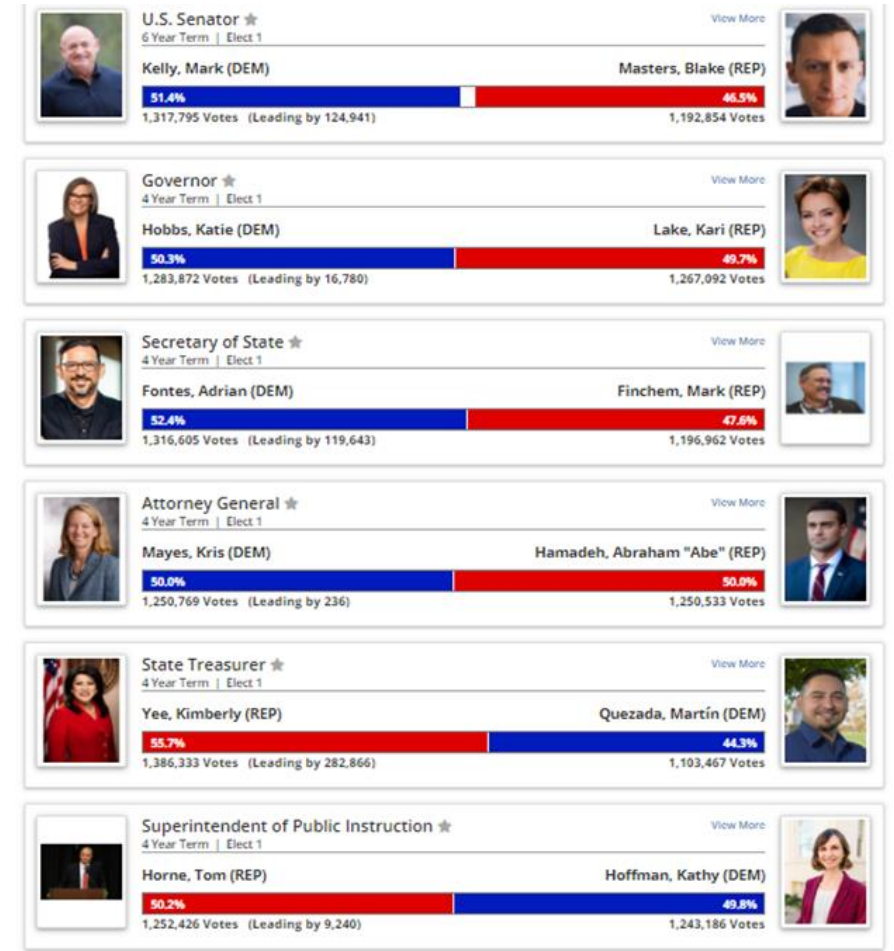
