Deputy Director of Human Resources Vicki Lackey explained that one presentation would be given for Item 19 and 20.

She explained that the request to amend article 7 of the Memorandum of Understanding with the Goodyear Police Officers Association will adjust the work period from seven to 14 days to provide greater flexibility in shift schedules and coverage. She added that overtime will be paid after 80 hours within the 14-day work period.

Chief of Police Brian Issitt explained that the proposed changes will allow more flexibility for scheduling police personnel and reduce overtime budget associated with shift coverage.

Acting City Clerk Jasmine Pernicano read Resolution No. 2025-2444 by title only.

In response to Council inquiry, Ms. Lackey explained that there are special circumstances for emergency responders. She confirmed that there was legal support for this change. Chief Issitt added that the proposed changes were made in collaboration with the GYPOA.

Council thanked staff for their work on the proposal.

Council discussed the location of the new gate, adjustments to the current parking canopy, and how deliveries would be handled. Council expressed support for the badge access and overall improvements.

CITY COUNCIL ACTION REPORT

SUBJECT: LETTER AGREEMENT WITH 29SC COTTON MFR PROPERTY OWNER, LLC. REGARDING SETTLEMENT OF INFRASTRUCTURE OBLIGATIONS

SUMMARY

29SC Cotton MFR Property Owner, LLC. ("Developer") is developing a project called The Artesian Casitas, which includes construction of certain off-site infrastructure improvements ("Project"). The city determined that the Project requires construction of an eight-inch (8") water line within 175th Avenue. The Developer disagreed with this determination. However, to resolve the dispute, the Developer has offered, and the city has agreed to accept, an in-lieu payment contribution payment from the Developer in the amount of \$165,523.64, which shall be applied to the cost of the future construction of the water line.

An in-lieu payment of \$165,523.64 will be provided by the Developer to the city and will be allocated to the future construction of an eight-inch (8") water line within 175th Avenue.

BACKGROUND AND PREVIOUS ACTIONS

The Developer is constructing a multi-family residence, which is generally located at the southeast corner of 175th Avenue and Lower Buckeye Road. As part of the development, the Developer is required to construct the Project, which includes construction of an eight-inch (8") water line on the western boundary of 175th Avenue. The city issued construction permits to the Developer for plans that did not include construction of the 8" water line. In lieu of requiring the Developer to construct the 8" water line, the city has agreed to accept a one-time payment for the Developer's portion of the estimated cost of constructing the water line, which is expected to be needed in the future.

STAFF ANALYSIS

Staff worked with the Developer on a Letter Agreement (Attachment A) that formalizes this agreement to settle the Developer's infrastructure obligations related to the Project.

Dear Mr. Knudson,

As the City of Goodyear, an Arizona municipal corporation (the "City") is aware, 29SC Cotton MFR Property Owner LLC, a Delaware limited liability company ("Developer"), owns certain real property in the City at the southeast corner of 175th Avenue and Lower Buckeye Road on which it is developing a project called The Artesian Casitas, which includes the construction of certain off-site infrastructure improvements (collectively, the "Project"). The Project is subject to that certain Development Agreement for Cotton Commons recorded in the Official Records of the Maricopa County Recorder at Instrument No. 2016-0423816 (the "Development Agreement").

The Development Agreement obligates Developer to make certain off-site infrastructure improvements required by the City Engineer and the Development Regulations (as both terms are defined in the Development Agreement). Prior to commencing construction of the Project, Developer submitted plans and specifications for all on- and off-site improvements relating to the Project (the "Drawings"), which Developer and Developer's design team believed were in compliance with the Development Agreement and all Development Regulations. The City reviewed and approved the Drawings and thereafter issued permits for the construction of the Project.

Following the City's issuance of permits and Developer's commencement of construction of the Project, the City concluded that the Drawings should have included an eight inch (8") water line in 175th Avenue along the western boundary of the Project (the "**Water Line**"). Developer disagreed. The parties concluded that it was in their best interests to resolve their disagreement quickly and for the City to allow the construction of the Project to proceed in accordance with the Drawings, as approved and permitted.



In full settlement of their disagreement, the City has agreed to accept from Developer, and Developer has agreed to pay to the City, the sum of \$165,523.64 in lieu of constructing the Water Line. The City agrees that upon payment by Developer of the foregoing sum and completion by Developer of the off-site infrastructure work contained in the Drawings, Developer will be deemed to have fully complied with and satisfied all of its obligations under the Development Agreement and the Development Regulations pertaining to the construction of the Water Line. Developer and the City mutually release and waive all claims either may have against the other relating to or arising out of the City's requirement of the construction of the Water Line and the City's approval of construction plans for improvements to 175th Avenue that did not include the Water Line. This mutual release and waiver extends to, but is not limited to, any claim the City may have to reimbursement from Developer for the future construction of the Water Line.

By signing below, the City and Developer hereby agree to the terms of this letter agreement with the intent of being bound hereby.

SUMMARY

Ambulance service to the citizens of Goodyear is currently provided by the Goodyear Fire Department, Maricopa Ambulance and Mutual-Aid partners.

The Intergovernmental Government Agreement between Surprise Fire-Medical and the Goodyear Fire Department will ensure uninterrupted ambulance transport services during times of peak overload, simultaneous emergencies, and during major emergency incidents.

STRATEGIC PLAN ALIGNMENT





RECOMMENDATION

Approve IGA with Surprise Fire-Medical Department and providing authorization and direction to take actions and execute documents necessary to carry out the intent of the agreement. (Paul Luizzi, Fire Chief)

FISCAL IMPACT

Each agency shall be responsible for the costs associated with providing ambulance transport services. There will be no financial impact to the Fire Department budget by entering into this agreement. Rates and costs associated with ambulance transport services are in compliance with applicable laws and will be billed accordingly.

BACKGROUND AND PREVIOUS ACTIONS

This is the first formal ambulance agreement between Surprise Fire-Medical and the City of Goodyear, and is included as Attachment A.

STAFF ANALYSIS

The Surprise Fire-Medical Department and the City of Goodyear have been partners since December 1999. This agreement enhances our current automatic aid agreement by adding a back-up ambulance transport services agreement. Each agency will provide interim ambulance transport services during times of peak overload, simultaneous emergencies, and major emergency incidents, in accordance with Arizona Department of Emergency Medical Service Emergency Certificate of Necessity A.R.S 36-2234.

GROUND AMBULANCE MUTUAL AID AGREEMENT BETWEEN GOODYEAR FIRE AND SURPRISE FIRE-MEDICAL DEPARTMENT

This agreement ("Agreement") is made and entered into effective on the <u>th</u> day of <u>("Effective Date")</u>, between Goodyear Fire, an agency of Goodyear, Arizona, a municipal corporation ("Goodyear") and Surprise Fire-Medical Department, an agency of Surprise, Arizona, a municipal corporation ("Surprise") both herein at times referred to collectively as "Agencies" or individually as "Agency" for the purpose of this Mutual Aid Agreement.

WHEREAS, Goodyear and Surprise recognize the necessity to cooperate and work together to provide for mutual aid and contingency assistance at certain times when either Agency requests such mutual aid for ground ambulance transport or assistance;

WHEREAS, both Goodyear and Surprise are signers of the Revised 2022 Intergovernmental Agreement for The Regional Metropolitan Phoenix Fire Service Automatic Aid (the "IGA");

WHEREAS, Article 5.2 of the IGA allows for entering into future agreements, or agreements to participate in more specific contracts for services, mutual assistance or automatic response(s); and

WHEREAS, State of Arizona Administrative Code Regulation R9-25-907. Observance of Service Area; Exceptions (A.R.S. §36-2232), identifies the need for a backup plan for mutual assistance.

NOW, THEREFORE, IT IS AGREED BY THE AGENCIES THAT HAVE DULY EXECUTED THIS AGREEMENT AS FOLLOWS:

SECTION 1. Mutual Aid and Contingency Agreement

The Agencies mutually agree to provide mutual aid ground ambulance service and contingency service to each other when resources are available to do so.

SECTION 2. Authority to Respond to Provide Assistance

The authority to make requests for assistance or to provide aid under this Agreement shall reside with the Phoenix Fire Regional Dispatch Center.

SECTION 3. Requesting Assistance

Either Agency may request assistance from the other Agency when it concludes that such assistance is essential to protect life or when either Agency is unable to provide adequate service levels to meet response requirements during periods of unusual system overload.

SECTION 4. Responses to Request

Upon request, the mutual aid responding Agency, upon determination that an emergency or contingency exists and subject in each instance to the availability of human and equipment resources as described in Section 5. below, shall dispatch EMS personnel and equipment to aid the requesting Agency.

SECTION 5. Personnel and Equipment Provided

The requesting Agency shall include in its request for assistance the amount and type of equipment, and shall specify the location where the personnel, equipment and supplies are needed. The final decision on the amount and type of equipment to be sent shall be solely that of the responding Agency. The responding Agency shall be immune from any liability in connection with all acts associated with the response provided. Neither Agency shall make any claim whatsoever against the other Agency for refusal to send the requested personnel or equipment (including refusal to deploy any resources).

SECTION 6. Command and Control at the Emergency Scene

Both Agencies have established Incident Command System (ICS) and Standard Operating Procedures (SOPs), as defined in the IGA, and will implement them on all incidents involving mutual aid or contingency responses. The responding Agency's personnel and equipment shall report to the incident commander. In the event no requesting Agency incident commander is on scene, then the responding Agency shall assume that command and follow their established SOP's.

SECTION 7. Record Keeping

Each Agency shall maintain individual patient care reports and dispatch records.

SECTION 8. No Reimbursement for Costs

Neither Agency shall be required to reimburse the other for the cost of providing the services set forth in this Agreement for mutual aid services. Each Agency shall pay its own costs (i.e. salaries, repairs, materials, compensation, etc.) for responding to requests for mutual aid or contingency response.

SECTION 9. Fees for Ambulance Service

Agencies providing ambulance transport or other services normally billed for will be entitled to recover from citizens their normal fees for service and are responsible for their own billing, insurance filing and collection activities.

SECTION 10. Liability

Each responding Agency hereby waives all claims against each requesting Agency for compensation for any property loss or damage and/or personal injury or death occurring as a consequence of the performance of mutual aid under this Agreement. The responding Agency assumes all liability and/or cost of damage to its equipment and the injury or death of its personnel when responding or performing mutual aid under this Agreement. The preceding sentence notwithstanding, the parties acknowledge that as public institutions, any indemnification or hold harmless provision shall be limited as required by State law, including without limitation Article 9, Sections 5 and 7 of the Arizona Constitution, and Sections 35-154 and 41-621 of the Arizona Revised Statutes.

SECTION 11. Insurance

Each Agency shall procure and maintain such insurance as is required by applicable federal and state law and as may be appropriate and reasonable to cover its staff, equipment, vehicles, and property, including but not limited to liability insurance, workers' compensation (if applicable), unemployment insurance, automobile liability, and property damage.

SECTION 12. Term of Agreement; Termination

This Agreement shall be in full force and effect upon execution by both Agencies. This Agreement shall automatically renew annually on the Effective Date, unless cancelled by either Agency by giving thirty (30) days written notice to the other Agency conforming with Section 14 below. This Agreement may be amended only by written agreement of both Agencies. As there is no contemplated acquisition of property for shared use by the Agencies, all property purchased by an Agency deployed under this Agreement, if not in possession of that Agency at the time, will be returned to that Agency upon termination of this Agreement.

SECTION 13. Attorney Confirmation

By their signatures below, the attorneys for each Agency have confirmed that this Agreement contains all statutorily required provisions and is in proper form, and that the person executing this Agreement for its client Agency is legally permitted to perform the duties and actions required or appropriately done by this Agreement.

SECTION 14. Miscellaneous

- A. Each Agency shall comply with all applicable state and federal laws, rules, regulations, and executive orders governing equal employment opportunity, immigration, and nondiscrimination, including the Americans with Disabilities Act. If applicable, the Agencies will abide by the requirements of 41 CFR §§ 60-1.4(a), 60-300.5(a), and 60-741.5(a). These regulations prohibit discrimination against qualified individuals based on their status as protected veterans or individuals with disabilities, and prohibit discrimination against all individuals based on their race, color, religion, sex, or national origin. Moreover, these regulations require that covered prime contractors and subcontractors take affirmative action to employ and advance in employment individuals without regard to race, color, religion, sex, national origin, protected veteran status, or disability.
- B. The grant will provide funds for regional education and development training opportunities such as implementing NFPA 1021, Fire Instructor I and Fire Officer I &II / Leadership for the purpose of protecting the health and safety of the public, and first responder personnel against fire and fire related hazards. The Glendale Fire Department has provided a Memorandum of Understanding ("MOU") outlining the federal share, department cost share, and number of participants per department.

STIPULATIONS

The City of Goodyear's share of the grant is \$285,225.53. There is a requirement that each west valley city agree to a 15% match of their award, which creates a match from Goodyear Fire totaling \$35,733.83 for up to 24 students, per the Memorandum of Understanding ("MOU") of the 2024 Assistance to Firefighters Regional Grant Award. The required grant match amount will be absorbed in the department's base budget.

FISCAL IMPACT

The total cost requested from Glendale was approximately \$2,705,385 (\$11,742 per firefighter). The City of Goodyear's share of the grant is \$285,225.53. There is a requirement that each west valley city agree to a 15% match of their award, which leave the city of Goodyear's match totaling \$35,733.83, absorbed in the department's base budget.

BACKGROUND AND PREVIOUS ACTIONS

The Glendale Regional Fire Department submitted the "AFG" grant award to FEMA on behalf of all west valley cities for regional education and development training funding. The MOU identifies the federal share and each department cost share, as well as the number of students/instructors eligible to participate in the available training.

STAFF ANALYSIS

The Goodyear Fire department supports the submission to request the "MOU" grant award submission for regional education and development training. It is a mutual benefit between the Goodyear Fire Department, Glendale Regional Fire Department and all other west valley cities to accept and utilize the grant award. Resolution to adopt this grant award is included as (Attachment A). The MOU is also included as (Attachment B).

HOST will be the City of Glendale Fire Department in accepting the Fiscal Year (FY) 2023 Assistance to Firefighters Grant ("AFG Grant") on behalf of itself and PARTNERS. The AFG Grant is utilized to implement NFPA 1021, Fire Instructor I and Fire Officer I&II/ Leadership for the purpose of protecting the health and safety of the public and first responder personnel against fire and fire-related hazards. The total amount awarded plus the participants 15% match totals \$2,705,385 (\$11,742 average per firefighter).

As part of the requirement for the AFG Grant, HOST and PARTNER are required to sign all documents being provided by either the HOST Fire Chief or Authorized Representative. HOST and PARTNERS agree to their portion of the **15% match.**

The total approved budget per the grant award is \$2,705,348.73, with \$2,352,477.15 awarded in Federal funding and a required match contribution of non-Federal funds equal to or greater than \$352,871.58. PARTNERS are required to submit a reimbursement request and associated supporting documentation to HOST for submission to FEMA. All PARTNERS will be reimbursed upon FEMA reimbursement to HOST agency.

PARTNER will pay all up front for their personnel costs and submit the required payroll reports to the HOST. The HOST will submit all required documents for FEMA reimbursement

HOST agency will pay all contractual costs up front associated with the student and or instructor. These costs include, but may not be limited to, the per student expense for course materials and testing fee from the Arizona Center for Fire Service Excellence. When a PARTNER submits all necessary payroll paperwork to the HOST for FEMA reimbursement, the HOST will submit for all pre-paid, per student contractual expense for FEMA reimbursement.

When the HOST receives approval and identified reimbursement amounts from FEMA, HOST will reimburse PARTNER.

SUBJECT: PENSKE TRUCK LEASING ANNEXATION

STAFF PRESENTER(S): Justin Gabrielson, Senior Planner

SUMMARY

This is a public hearing to consider the annexation of approximately 4.92 acres of property, generally located on the south side of West McDowell Road, just west of the 183rd Drive alignment.

STRATEGIC PLAN ALIGNMENT



RECOMMENDATION

Conduct a public hearing to consider the annexation of approximately 4.92 acres of property, generally located on the south side of West McDowell Road, just west of the 183rd Drive alignment. (Justin Gabrielson, Senior Planner)

FISCAL IMPACT

Annexation of land has a fiscal impact. A brief overview of anticipated public infrastructure and services impact is included in the staff analysis section of this report. A detailed fiscal impact will be included in future City Council reports. There is no fiscal impact associated with authorizing the staff to proceed with the state statutory requirements for annexation. Authorizing the process to move forward does not commit the City Council to approve the annexation.

BACKGROUND AND PREVIOUS ACTIONS

This item was previously heard by City Council on October 7, 2024, and City Council provided authorization to start the Annexation Process. The application request is for the annexation of approximately 4.92 acres of property generally located on the south side of West McDowell Road, just west of the 183rd Drive alignment (APN 502-37-064M) (the "Property") (Included as Attachment A - Aerial Exhibit). The Property is one of the five parcels located within a county island that is surrounded by property within the City of Goodyear.

The abutting property to the south of the Property, which is within the city's boundaries, is

owned by the Arizona Department of Transportation, and the property north of the Property, which is also within the city's boundaries, is Arizona State Trust Land and is the site of Perryville Prison. The abutting property to the east (APN 502-37-064C), which is within the city's boundaries (the "Penske Leasing Property"), is owned by Penske Truck Leasing Co. ("Penske"). The Penske Leasing Property was rezoned from I-1 to I-2 on August 29, 2022, and a site plan for the development of a Penske Truck Leasing Facility has been approved. Penske Truck Leasing Co. LP acquired the Property in March 2023.

STAFF ANALYSIS

Current Policy:

Arizona State Statutes regulates annexation. Below is a brief summary of the City's annexation process:

- Staff determines whether the proposed annexation area meets the state legal requirements for annexation as set forth in A.R.S. § 9-471.
 - The Property is located within the city's municipal planning area and staff has determined that the annexation area meets the state legal requirements for annexation pursuant to the provisions of A.R.S. § 9-471 (K).
- Assuming the proposed annexation area meets the state legal requirements for annexation, staff conducts a review of the annexation proposal to determine the desirability of the annexation.
- Staff provides an impact analysis of the annexation proposal to City Council. The City Council will consider the proposal and make a determination on whether to authorize staff to proceed with the annexation.
 - If authorization is not provided, the annexation application will be denied, and no further action on the annexation will be taken.
 - If authorization is provided, staff will move forward with processing the annexation application.
 - City Council considered the proposal on October 7, 2024 and authorized staff to move forward with processing the annexation application.
- After further staff review of the proposal, a blank petition containing the legal description
 and an accurate map of the annexation territory is filed with the County Recorder and
 notice and a copy of the filing shall be given to the clerk of the board of supervisors and
 to the county assessor. The description shall identify the entity, if any, that will be
 responsible for maintaining the existing rights-of-way and roadways that are within or
 contiguous to the exterior boundaries of the area of the proposed annexation.
- After the blank petition is filed, there is a 30-day waiting period before signatures can be obtained. A public hearing must be held within the last 10 days of this 30-day waiting period to receive public input on the annexation. The first of two public hearings must be held within the last 10 days of this 30-day waiting period to receive public input on the annexation. Notices of the public hearing must be: (i) published in a newspaper of general circulation at least fifteen days before the end of the 30-day waiting period and six (6) days before the public hearing; (ii) be posted in at least three conspicuous public places in the area being annexed at least six (6) days before the public hearing; (iii) sent by first class mail to the chairperson of the board of supervisors of the county in which The Property being annexed is located at least six (6) days before the public hearing; (iv) sent by first class mail, with an accurate map of The Property being annexed to each owner of the real and personal property as shown on the statement provided by the county assessor and department of revenue at least six (6) days before the public hearing.
 - The public hearing being held on February 10, 2025, is the first of the two public hearings required for annexation and it is being held within the last ten (10) days of

the 30-day waiting period. Notices of the public hearing being held on February 10, 2025, for the annexation was published in the Arizona Republic West Valley Edition on January 24, 2025, which is at least fifteen days before the end of the 30-day waiting period and at least six (6) days before the public hearing. On January 24 2025, notices of the public hearings were also posted in three conspicuous places in each of the properties proposed to be annexed, which is at least six (6) days before the public hearing. On January 17, 2025, notices of the public hearing along with an accurate map of the Annexation Area for each of the proposed annexations was emailed to the County Board of Supervisors; to the County Assessor; and to the owner of real and personal property identified on the lists received from the Maricopa County Assessor and Arizona Department of Revenue, which is at least six (6) days before the public hearing.

- After the first public hearing and after the 30-day waiting period is over, the blank petition may be signed and collected.
- Once signatures have been collected on the blank petition, an annexation ordinance is prepared, and a second public hearing is held for Council's consideration of the Ordinance. If approved by Council, the signed petitions and required affidavits will be filed with the Maricopa County Recorder and a copy of the Annexation Ordinance is submitted to the Clerk of the Board of Supervisors for Maricopa County.

NEXT STEPS

Following the public hearing on February 10, 2025, the applicant will be able to circulate the blank petitions for signature. Once that is done, the applicant will submit the signed petitions to the City. Assuming the petitions submitted satisfy the statutory requirements for an annexation to occur, the annexation will be scheduled for a city council meeting for final consideration by the City Council.

Details of the Request:

The February 10, 2025 public hearing is to receive public input on a pending application for annexation of the following:

• Approximately 4.92 acres of property, generally located on the south side of West McDowell Road, just west of the 183rd Drive alignment.

The Property is generally located on the south side of West McDowell Road, just west of the 183rd Drive alignment, and is owned by Penske Truck Leasing Co LP.

The Property is 4.92 acres in size and is within the "Neighborhood" Land Use Designation under the city's General Plan. The existing County zoning for the annexation area is Light Industrial (IND-2). The uses under the County's Light Industrial (IND-2) zoning district are consistent with the city's General Industrial Park (I-2) zoning district. Accordingly, upon annexation, the Property would be designated the city equivalent zoning district of General Industrial Park (I-2).

Although the I-2 zoning district is inconsistent with the Neighborhood Land Use Designation; the Property is already zoned Industrial and could be developed under the existing Maricopa County zoning with industrial uses. Consequently, a General Plan Amendment would not be required upon annexation because the parcel would already be zoned I-2.

If the annexation is ultimately approved by Council, the city could, following the effective date of the annexation ordinance, formally begin the review for Penske Truck Rental Site Expansion and issue necessary permits to begin development.

City's Annexation Policy

The Goodyear City Council adopted an annexation policy by Resolution 2001-768 that provides staff with guidelines for the evaluation of annexation requests:

- 1. The City's ability to provide basic services in a timely manner.
- 2. Long-term desirability for community development and economic growth
- Likelihood of the area being developed in Maricopa County or being annexed by another city or town.
- 4. Ability to control the quality of land uses and infrastructure standards.
- 5. Compatibility with General Plan, infrastructure needs, and timing of development

As discussed above, the Property was acquired by Penske for the development of a parking lot to support its truck leasing operations being developed on the Penske Leasing Property. *Streets:* The Property is located on the south side of West McDowell Road. The developer would be responsible for the construction of The Property's half-street improvements. *Public Safety:* The Property is located within an existing Police patrol beat and the current level of service within the beat can accommodate the development of the Property. Fire services will be provided by Station 188, which is located approximately 2.23 miles away from the site and Station 185 located 5.38 miles northwest of the site.

Water: The Property is within the service area of Arizona Water Company. Therefore, there is no impact on the city's water portfolio or any infrastructure needed to provide water service to the Property.

Wastewater: The Property is located within the city's wastewater service area, and the city will be providing wastewater service to the Property. There is an existing trunk line located within West McDowell Road that should have capacity sufficient to meet the wastewater flows that will be generated by the development of the Property. If the existing trunk line cannot accommodate wastewater flows from The Property, The Property owner will be required to install any additional improvements needed for the city to provide wastewater to the Property.
