

**RESOLUTION NO. 8503**

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HAWTHORNE, CALIFORNIA, RECITING THE FACTS OF THE GENERAL MUNICIPAL ELECTION HELD IN SAID CITY ON TUESDAY, NOVEMBER 5, 2024 AND DECLARING THE RESULTS THEREOF AND SUCH OTHER MATTERS AS ARE PROVIDED BY LAW.**

**WHEREAS**, a general municipal election (the "Election") was held and conducted in the City of Hawthorne, California on Tuesday, November 5, 2024 as required by law; and

**WHEREAS**, the Election was consolidated with other elections held on the same date; and

**WHEREAS**, the Registrar-Recorder of the County of Los Angeles canvassed the returns of the Election and certified the results to this City Council, and such canvass is received, attached and made a part hereof as Exhibit "A"; and

**WHEREAS**, notice of the Election was given in time, form and manner as provided by law, and that in all respects the Election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Election Code of the State of California; and

**WHEREAS**, the City Council desires to declare the results of the Election pursuant to Elections Code Section 10263.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Hawthorne does hereby find, determine and order as follows:

**Section 1.** That the recitals in this resolution are true and correct and are herein incorporated. That the number of votes given at each precinct to each candidate are provided in Exhibit "A", attached herein.

**Section 2.** That the whole number of votes cast in regards to Mayor, and City Council in the City was 26,882.

**Section 3.** That the names of persons voted for at the election for Mayor and the total votes received by each are as follows:

**Section 4.** That the names of persons voted for at the election for Member of the City Council and the total votes received by each are as follows:

**Section 5.** The City Council does determine and declare that:

ALEX VARGAS was elected Mayor for the full term of four years;

ANGIE REYES ENGLISH was elected as a Member of City Council for the full term of four years;

FAYE JOHNSON was elected as a Member of City Council for the full term of four years;

**Section 6.** That the City Clerk shall immediately certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.
