

RESOLUTION NO. 8501

A RESOLUTION OF THE CITY OF COUNCIL OF THE CITY OF HAWTHORNE, CALIFORNIA, DESIGNATING AUTHORIZED AGENTS TO EXECUTE FOR AND ON BEHALF OF THE CITY OF HAWTHORNE FOR FINANCIAL ASSISTANCE FROM THE FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) AND THE CALIFORNIA OFFICE OF EMERGENCY SERVICES (CalOES) FOR RECOVERING COSTS ASSOCIATED WITH DECLARED EMERGENCIES

WHEREAS, the City of Hawthorne participates in the costs recovery process of disasters administered by the California Officer of Emergency Services; and

WHEREAS, the California Office of Emergency Services requires local government to designate authorized agents; and

WHEREAS, Cal OES Form 130 designates a city's authorized agents when seeking financial assistance after a Governor or Presidential disaster proclamation; and

WHEREAS, The City Council of the City of Hawthorne wishes to adopt Resolution No. 8501, designating authorized personnel to act as agents for the City when seeking financial assistance after a disaster on Cal OES Form 130, which is attached and incorporated herein as Exhibit A.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF HAWTHORNE, CALIFORNIA, hereby resolves as follows:

Section 1. That the recitals of facts set forth above are true and correct and are incorporated into this Resolution by this reference.

Section 2. That the City Council of the City of Hawthorne approves submittal of Cal OES Form 130 designating the City Manager, Police Chief, Public Works Manager, and Legal Risk Specialist as designated agents to execute for and on behalf of the City of Hawthorne for financial assistance from the Federal Emergency Management Agency (FEMA) and the California Office of Emergency Services (Cal OES) for recovering costs associated with declared emergencies. This form shall be valid for three (3) years.

Section 3. That any resolutions in conflict with this Resolution No. 8501 are hereby rescinded and superseded.

Section 4. The City Clerk shall certify to the adoption of this Resolution and shall cause this Resolution and their certification to be entered into the Book of Resolutions of the Council of the City of Hawthorne.
