

RESOLUTION NO. 8591

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HAWTHORNE, CALIFORNIA AUTHORIZING THE THIRD AMENDMENT FOR CONSULTANT SERVICES ENTERED INTO MARCH 14, 2026 THROUGH MARCH 14, 2027, BETWEEN THE CITY OF HAWTHORNE AND CITIGUARD INCORPORATED.

This third Amendment to City of Hawthorne Agreement for Consultant Services (“Third Amendment”) is made and entered into as of March 14, 2026 (“Effective Date”), by and between the City of Hawthorne, a municipal corporation (“City”), and Citiguard Inc, a California corporation (“Consultant”) (collectively, the “Parties”) with reference to the following:

WHEREAS, City and Consultant entered into an Agreement for Consultant Services dated March 14, 2023, to provide security services to the Bridge of Hope Community Housing project;

WHEREAS, City and Consultant now desire to extend the term for one (1) year, through March 13, 2027 (the “Extended Period”); and

WHEREAS, City desires to set forth Consultant’s maximum compensation and scope of services for the Extended Period accordingly.

NOW, THEREFORE, THE CITYCOUNCIL OF THE CITY OF HAWTHORNE DOES RESOLVE, DECLARE, DETERMAINE, AND ORDER AS FOLLOWS:

Section 1. Defined Terms. Except as otherwise defined herein, all capitalized terms used herein shall have the meanings set forth for such terms in the Original Agreement.

Section 2. Revised Scope of Services. The Scope of Services, Exhibit "A" attached hereto and incorporated herein by this reference.

Section 3. Term. The Term of the Original Agreement as set forth in Section 1 therein began on March 14, 2023, and continues on an as-needed basis unless earlier terminated. This Third Amendment hereby amends Section 1 of the Original Agreement to provide for a one (1) year term from March 14, 2026 to March 13, 2027. All other language in Section 1 of the Original Agreement shall remain unchanged.

Section 4. Insurance. The insurance requirements set forth in Exhibit “B” all terms thereof shall remain in full force and effect during the Extended Period.

Section 5. Compensation. The total not-to-exceed compensation set forth in Exhibit A is the sum of Two Hundred Thirty-Seven Thousand Nine Hundred Sixty-One and 00/100 Dollars (\$237,961.00).

Section 6. Integration. This Third Amendment and all attachments hereto (if any) integrate all of the terms and conditions mentioned herein, and supersede all negotiations with respect hereto. This Third Amendment amends, as set forth herein, the Original Agreement and except as specifically amended hereby, the Original Agreement shall remain in full force and effect. To the extent that there is any conflict or inconsistency between the terms and provisions of this Third Amendment and the terms

and provisions of the Original Agreement, the terms and provisions of this Third Amendment shall control.

Section 7. This Resolution shall become effective immediately upon its adoption.

Section 8. The City Clerk shall certify to the adoption of this resolution.
