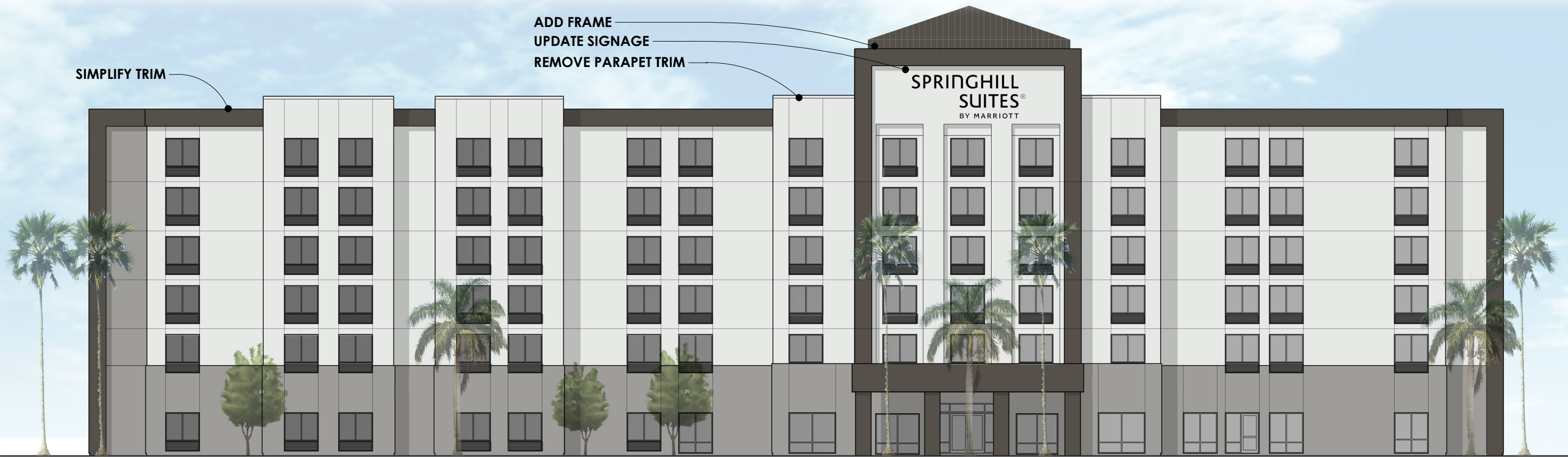

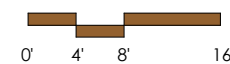

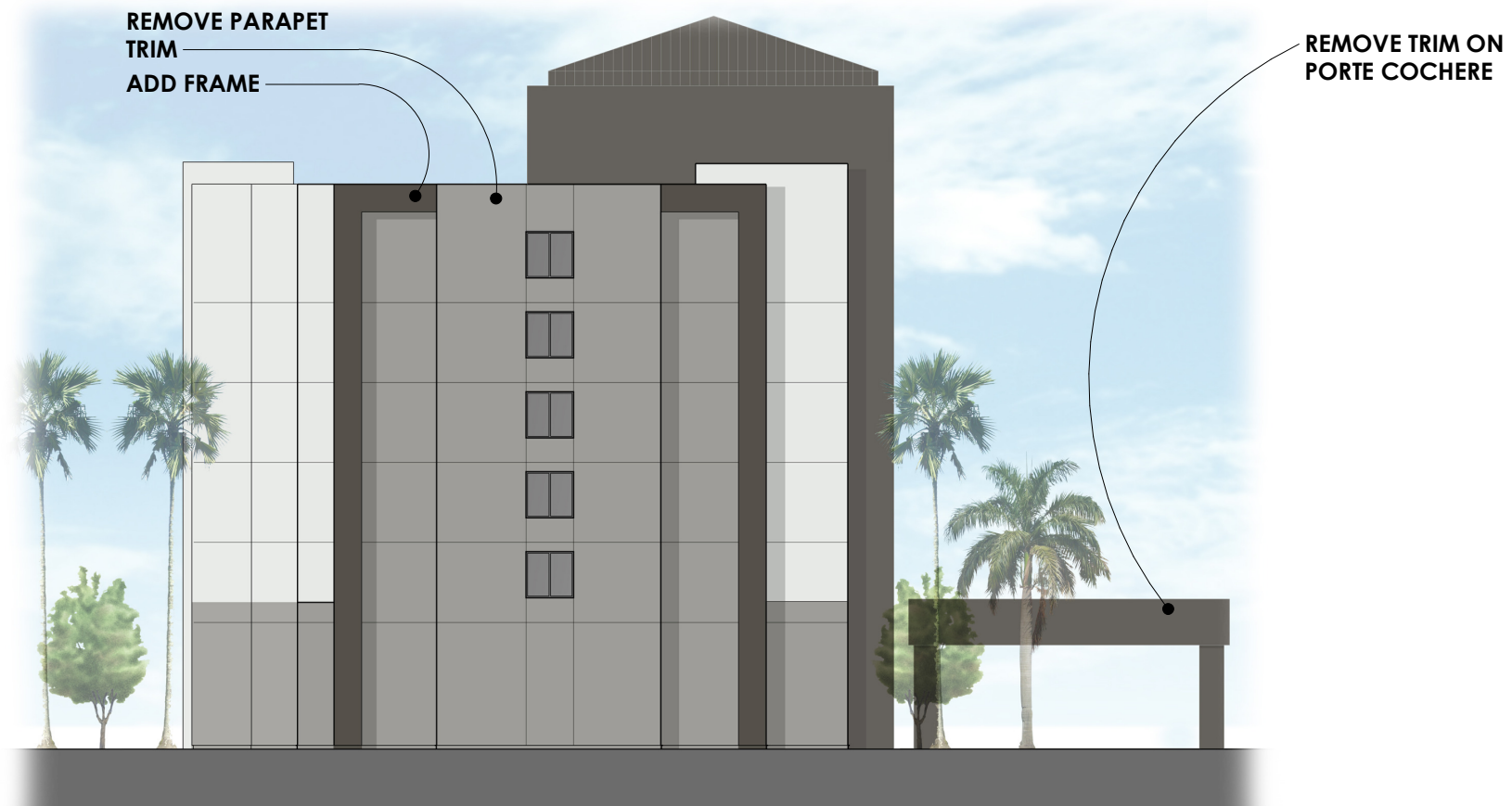

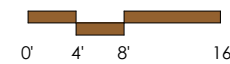

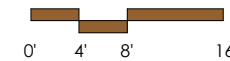


NORTH ELEVATION - PROPOSED

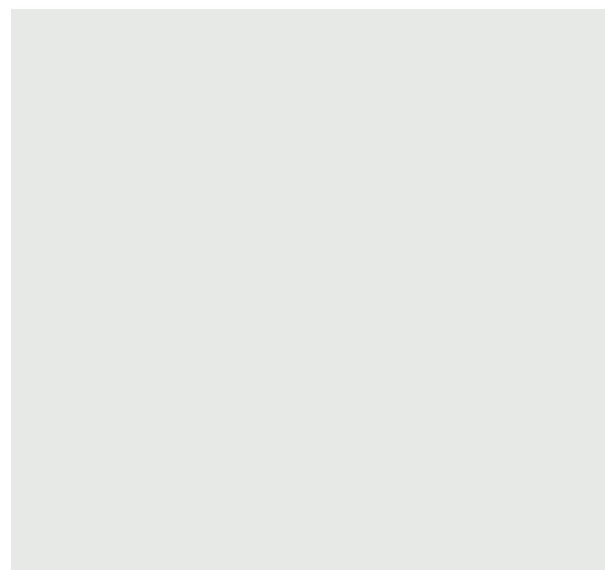
