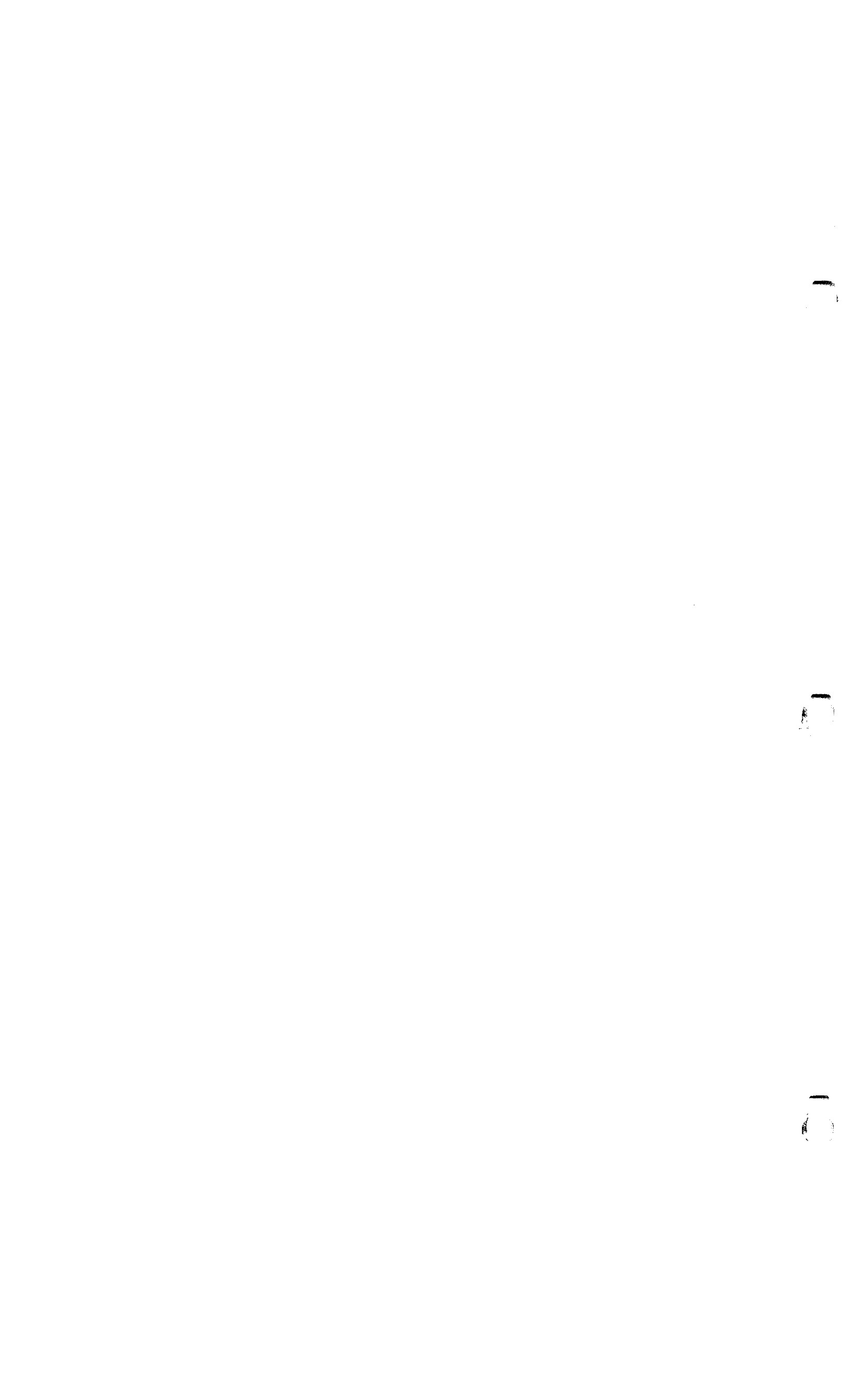

EXECUTIVE SESSION/OPEN SESSION/JESUS NAVARRO

An Executive Session was held before Commissioners' Court. Jesus Navarro requested this hearing to appeal the decision of termination from the Department of Community Affairs. Mr. Jesus Navarro was represented by his attorney Mr. Ramon and the attorney representing the Department of Community Affairs was Mr. Charles Willette. Witnesses on behalf of Jesus Navarro came before a quorum and documents of evidence by both parties were furnished.

Court was resumed on Monday, July 9, 1990 at 1:33 P.M. in the afternoon. All the testimony that was to be presented by both parties was heard and questions about a fair and impartial hearing were asked of Mr. Jesus Navarro and his attorney where they agreed to the fairness of the Court. Mr. Navarro also agreed that he had been given all the time necessary to present any and all witnesses or documents etc. for his case.

Mr. Travis Heister stated for the record that the Commissioners' were not there to discuss a decision but, in essence to deliberate on the matters based on this case.

Judge Ruiz recommended that based on the testimony presented, Mr. Jesus Navarro be reinstated to his position as Planning Officer and that he be fully compensated of all his salary and fringe benefits that he would have earned as Planning Officer. This action is to take effect from the date of termination.

A motion was made by Commissioner Camarillo, seconded by Commissioner Arcaute to said recommendation.

MOTION CARRIED.

There being no further business to come before the Court, a motion was made by Commissioner Arcaute, seconded by Commissioner Cavazos, that said meeting of Commissioners' Court be hereby adjourned.
