#### **A. Canvass the November 03, 1998 General election Returns**

Noe Perez, Elections Administrator, came before the Court to present the returns for the 1998 General Election. He stated that a total of 49,147 votes had been cast with 15,842 of those votes being cast during the early voting period and 33,305 votes being cast on Election Day. Mr. Perez also stated that after these returns were canvassed and certified he would be sending the results to the Secretary of State's Office. A discussion ensued with regards to how this election compare to the previous election and some of the problems that were encountered this time around. A motion was then made by Commissioner Rosel to approve the canvassing of the votes for the 1998 General Election. Upon a second by Commissioner Handy, the motion carried.
