PACKAGE BEHICLES

Tarrant County has received confirmation from Philpott Ford and Ford Motor Company that their prices on Bid No. 2001-125-Joint Venture/Cooperative Purchase of Police Package Vehicles for Various Departments/Variou Entities will remain firm for the 2007 year models. We renewed their contract through Commissioners Court on May 23, 2006. As spelled out in the Philpott's original bid, the \$400.00 deduct for early order incentive from Ford Government Sales expired on 11/16/01. Philpott Ford and Ford Motor Company lowered the base price of 2006 model Crown Victoria Police Package Vehicle by 400.00, resulting in a base price of 18,907.00. When ordering 2007 models use the \$18907.00 base price and add options as needed to equip your vehicles. The contact person is Emmett Cone at (817) 429-2557. He will be glad to assist you with pricing and options. Philpott Ford's contract covers the Police Package Crown Victoria, Explorer, and Expedition.

Enclosed with this memo please find a copy of the bid awards approved by Commissioners Court on Sept 18, 2001. The spreadsheets show the actual prices for base bids and options. Please contact Emmett Cone for the actual F.O.B. delivery charges per vehicle per entity. With the renewal of this contract we have agreed to add a \$50.00 Fuel Surcharge for each 2007 model ordered to cover the rising cost of fuel since 2001. Do not use the common average delivery charges shown on the enclosed award spreadsheet, since these numbers were used as an add-on amount for each bidder in the original evaluation process.

Remember that effective July 1, 1999, Ford Fleet Sales requires each fleet customer to have a Fleet Identification Number (FIN) code. This code insures that warranty or recall information is forwarded to the proper customer personnel. A FIN code is required for the dealer to report a vehicle sold and to register the factory warranty. If you do not already have a FIN Number, your may call Ford at 1-800-343-5338, extension #1.

## INTERLOCAL AGREEMENT

### BETWEEN COUNTY OF TARRANT AND COUNTY OF HIDALGO TEXAS

This agreement is made this \_\_\_\_\_ day of \_\_\_\_\_, 2006 between the County of Tarrant, Texas and the County of Hidalgo, Texas.

Pursuant to the authority granted by the "Texas Interlocal Cooperation Act," Chapter 791 Texas Government Code providing for the cooperation between local governmental bodies, the parties hereto, in consideration of the premises and mutual promises contained herein, agree as follows:

WHEREAS, the contract is made under the authority of Sections 791.001-791.029 of the Texas Government Code; and,

WHEREAS, the parties, in performing governmental functions or in paying for the performance of governmental functions hereunder shall make that performance or those payments from current revenues legally available to that party;

WHEREAS, the governing bodies of each party find that the subject of this contract is necessary for the benefit of the public and that each party has the legal authority to perform and to provide the governmental function or service which is the subject matter of this contract; furthermore, the governing bodies find that the performance of this contract is in the common interest of both parties; and that the division of cost fairly compensates the performing party for the services under this contract.

#### I.

the County of Hidalgo, hereby makes, constitutes and appoints Tarrant County its true and lawful purchasing agent for the purchase of various commodities using Annual Contracts (Bids). Tarrant County will maintain a listing of Annual Contracts which are available for local entities use. Tarrant County will forward a copy of requested Annual Contract for the requesting entity use. the County of Hidalgo agrees that Tarrant County shall serve as the purchasing agent for selected items, and agrees that the bidding shall be conducted by Tarrant County according to its usual bidding procedures and in accordance with applicable State statutes.

**II.**

the County of Hidalgo agrees that all specifications for selected items shall be determined by Tarrant County.

**III.**

the County of Hidalgo agrees to pay the supplier for all goods, equipment and products pursuant to this agreement. The successful bidder or bidders shall bill the the County of Hidalgo directly for all items purchased, and the the County of Hidalgo shall be responsible for vendor's compliance with all conditions of delivery and quality of the purchased items.

**IV.**

**V.**

This agreement shall take effect upon execution by both signatories.

**VI.**

This agreement shall be in effect from the date of execution until terminated by either party to the agreement
