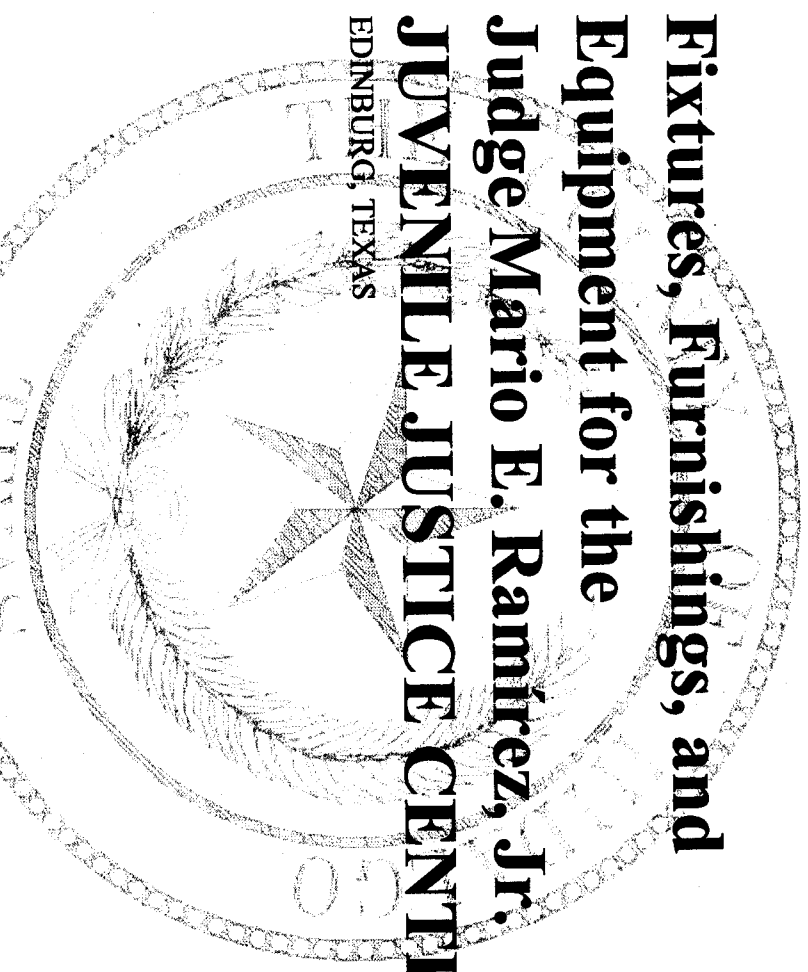

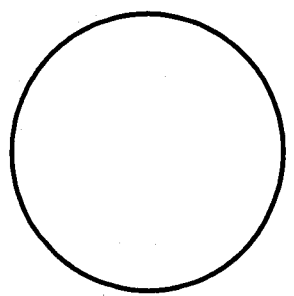

DIVISION 1 - GENERAL REQUIREMENTS

01010 SUMMARY OF WORK:

1. SUMMARIES:

1.1 Location: 1001 N. Doolittle Road, Edinburg, Texas

1.2 Cooperation: The Contractor, all other Contractors and all sub-contractors shall coordinate their work with all adjacent work and shall cooperate with all other trades so as to facilitate the general progress of the work. Each trade shall afford all other trades every reasonable opportunity for installation of their work and storage of their materials.

1.3 Inspection and Test: The Architect and his representatives shall at all times have access to the work whether it is in preparation or in progress. The Contractor shall Provide proper and safe facilities for such access and inspection. Make all inspections and tests in connection with this entire contract as required by the Architect. All testing shall be paid for by the Owner and be done by and independent testing laboratory meeting the approval of the Architect. Any cost of re-testing required due to failure of the Contractor at no expense to the Owner.

1.4 Checking Dimensions at site: Before ordering any materials or doing any work, Contractor shall verify all measurements of the building and be responsible for the corrections of them. No extras will be allowed for variations from drawings in existing conditions or for work performed under this contract. Any discrepancies found shall be submitted to the Architect for instructions before proceeding.

1.5 PROJECT MEETINGS

1. Pre-Construction conference:

- a. Will be scheduled by the Architect within five days after Notice to Proceed.
- b. No work shall commence until this meeting has been successfully completed.
- c. Attendance is mandatory for the Contractor and representatives of all subcontractors listed on the Proposal Form. Should any subcontractor not be in attendance, the meeting will be rescheduled. No allowances will be made for extensions of time due to any delay to the commencement of work caused by the absence of a subcontractor from this meeting.

- 2. **PERMITS, LAWS, CODES, ETC.:** Contractors shall comply with all Federal, State and local laws, codes, and ordinances applicable to the work and all requirements of the National Board of Fire Underwriters having jurisdiction. If the above laws, codes or ordinances conflict with Specification, then the laws, codes or ordinances shall govern except where Specification exceeds them in quality or quantity of materials or labor. Obtain and pay for all permits required in connection with the execution of the work. Under no circumstance shall any work be started before the required permits are obtained. Architect shall be furnished with certified copies of these permits if he so requests.
- 3. **COOPERATION WITH BUILDING OFFICIALS:** Cooperate with local and other governmental officials and inspectors at all times. If such official or inspector deems special inspection necessary, provide assistance and facilities that will expedite his inspection.
- 4. **MANUFACTURER'S SPECIFICATIONS AND INSTRUCTIONS:**
 - a. Install all manufactured items, materials and equipment in strict accordance with the manufacturer's recommended specifications, except that the Specifications herein, where more stringent, shall be complied with.
 - b. At the completion of the project and prior to final acceptance by Owner, provide Owner with one complete set of operating and maintenance instructions, and demonstrate to him the procedures for proper operation and maintenance of all equipment.

5. MEASUREMENTS: Before doing any work or ordering any materials, Contractor shall verify all measurements of existing and new work and shall be responsible for their correctness. Any difference which may be found shall be submitted to Architect for consideration before proceeding with the work. No extra compensation will be allowed because of difference between actual dimensions and measurements indicated on the Drawings.
6. RECORD DRAWINGS:
 - a. Provide and maintain in proper order and in good clean condition, one complete set of blueline prints of all project drawings.
 - b. Prior to final payment, as-built drawings meeting the approval of the Architect shall be delivered to the Owner.
7. JOB MAINTENANCE:
 - a. During the course of their work, all crafts and trades shall protect all work which precedes theirs from damage and they shall make repairs or replacement of any damage caused either directly or indirectly by them at no cost to the Owner.
 - b. Site housekeeping and final cleaning shall be done in accordance with requirements of Division C and Section 01700.
8. PROTECTION: Provide barricades, fences, lights, etc., for protection of property and the public as required by local and/or State ordinances.
9. LOADS AND STRESSES FROM CONSTRUCTION OPERATIONS:
 - a. Contractor shall have full responsibility for preventing overstress of any and all parts of the structure during construction operations.
 - b. Provide all temporary supports and connections necessary to assure the safety and stability of all work in place and to prevent overstress of any part thereof.
11. ADA REQUIREMENTS: All contractors and/or material suppliers providing items which are subject to specific requirements addressed in the Americans With Disabilities Act (ADA) accessibility guidelines are required to ensure that their work or materials meet the letter of this law. Any discrepancies between the Contract Documents and the ADA requirements **will not** alleviate the Contractor or Material Suppliers of their responsibility to comply with ADA guidelines and will not be an acceptable reason for additional compensation.

12. PROTECTION OF WORK AND PROPERTY AND INDEMNIFICATION

The CONTRACTOR shall continuously maintain adequate protection of all its work from damage and shall protect the OWNER'S property from injury or loss arising in connections with this CONTRACT. The CONTRACTOR shall indemnify, defend and save the OWNER harmless from and against any and all loss, costs, claims or liability for damages of any kind arising or alleged to have arisen from the negligent acts or omissions of the CONTRACTOR, its agents, employees or subcontractors to carry insurance as specified.

The CONTRACTOR shall take all necessary precautions for the safety of all persons on the Work and shall comply with all applicable provisions of Federal, State and Municipal safety Laws to prevent accidents an injury to persons on or adjacent to the premises where the Work is being performed. The CONTRACTOR shall erect and properly maintain at all items, as required by the conditions and progress of the Work, all necessary safeguards for the protection of workmen and the public, and shall post danger signs warnings against the hazards created by the various construction activities during the effective period of this CONTRACT.

In an emergency affecting the safety of life or of the Work or of adjoining property, the CONTRACTOR, without special instructions or authorization from the OWNER, is hereby permitted to act, at its discretion, to prevent such threatened loss or injury and the CONTRACTOR shall also act if instructed or authorized to do so by the OWNER.

13. INSPECTION OF THE WORK (AS APPLICABLE)

Intentional deviations from the Contract by the Contractor and/or his subcontractors, who know that it is unlikely for the Architect to discover such discrepancies during construction without in depth investigations, shall not be deemed to have been accepted when the Application is approved.

Approval of the Contractor's Application for Payment does not mean that approval has been granted for an installation not in compliance with the Contract Documents. It is the Contractor's duty and responsibility under the contract to comply with all of the provisions in the Contract.

SECTION 01340 - SUBMITTALS**1.00 GENERAL**

- A. This Section is subject to the provisions and requirements of all Contract Documents.
- B. **STIPULATIONS:**
1. Types of submittal requirements, covered by this Section, include administrative submittals, schedules, notifications, shop drawings, product data, samples and miscellaneous work-related submittals. Individual submittal requirements are included in certain Sections of the Specifications for units of work. Refer to these Sections and General Conditions for related requirements of various submittals.
 3. Letter of Transmittal: Each submittal shall be accompanied by Contractor's Letter of Transmittal identifying Contractor, Company or Supplier preparing submittal; date of transmittal; number of copies; desired action by Architect and name and phone number of person to contact for questions and/or clarification's.
 4. Identifications: Each item submitted shall be properly and sufficiently identified, and where possible, references to that part of the Drawings or Specifications to which it applies.
 5. Contractor shall arrange for and pay for all costs involved for the transfer of submittals to and from Architect's office.
- C. **SUBMITTAL ITEMS SHALL INCLUDE, BUT NOT NECESSARILY BE LIMITED TO:**
1. Shop drawings of all shop and/or factory-assembled, fabricated and/or semi or pre-finished items to be installed on the job.
 2. Samples of materials with complete range of colors and/or textures from which required selections can be made, noting any time of delivery restraints that may be required of particular selections. Contractor is advised that coordinated color selections will be required throughout the major areas of the building and that approval of various color selections will be contingent upon Contractor's submittal of all items requiring such coordination as a unit.
 3. Brochures and manufacturer's data shall include all special instructions regarding safety, installation sequences, and methods of assembly and installation.

2.00 PROCEDURES

- A. On first submittal, Contractor shall transmit (5) prints and one sepia to Architect and retain one print. Architect will retain prints and will stamp and return sepia to Contractor. After submittal has been reviewed, Contractor shall reproduce the number of copies needed for his use and for the use of his suppliers from the sepia.

- B. Follow same procedure for re-submittals as required for initial review.

3.00 USE OF ARCHITECT'S DRAWINGS

- A. Contractors, Sub-Contractors and Material Suppliers shall not have use of electronic drawing or plot files of any Drawings (Civil, Structural, Architectural, Mechanical, Electrical, etc.) that make up part of these Contract Documents, for the purpose of preparing any submittals required by the Specifications.

4.00 STATUS OF SUBMITTALS

- A. CONTRACTOR SHALL BE RESPONSIBLE FOR:

1. Timely transmission and scheduling of all submittals.
2. Grouping of all submittals requiring color coordination.
3. Reviewing all submittals for compliance with requirements of the drawings, specifications and general documents.
4. Any and all costs for corrective work required as a result of incorrect data appearing on any submittal, whether or not submittal has been reviewed and stamped by Architect.

SECTION 01600 - SPECIAL PROCEDURES

PART 1 - GENERAL

1.0 DESCRIPTION: Provide the following special procedures as described.

PART 2 - EXECUTION

2.01 ACCELERATION OF THE WORK

- a. If, in the judgement of the Architect or Owner, it becomes necessary at any time during the stipulated construction period to accelerate the work or a portion thereof, the Contractor when ordered or directed by the Architect, shall deploy the workmen in such portions of the project where directed, to enable others to properly engage and carry on their work.
- b. If, in the judgement of the Architect, the work is behind schedule and the rate of placement of work is inadequate to retain scheduled process so as to insure timely completion of the entire work or a separable portion thereof, the contractor, shall immediately take action to increase the rate of work placement. This increase shall be accomplished by any one or a combination of the following or other suitable measures:
 - 1. An increase in working forces.
 - 2. An increase in equipment or tools.
 - 3. An increase in hours of work or number of shifts.
 - 4. Expedite delivery of materials.

The Contractor shall within three (3) calendar days after being so informed, notify the Architect of the specific measures taken and/or planned to increase the rate of progress together with an estimate as to when scheduled progress will be regained. Should the plan of action be deemed inadequate by the Architect, the Contractor will take additional steps or make adjustments as necessary to his plan of action until it meets with the Owner's approval. The acceleration of work will continue until scheduled progress is regained. Scheduled progress will be established from the latest revised approved progress schedule for the job. Timely completion will be understood as the contract completion date is revised by all time extensions granted at the time acceleration is undertaken.

- c. The Contractor shall not be entitled to additional compensation for the additional effort he applies to the work under the terms of this sub paragraph.

2.02 WAIVER OF LIEN

It is distinctly understood that by virtue of this contract no mechanic, contractor, material man, artisan or laborer, whether skilled or unskilled, shall ever in any manner have claim or acquire any lien upon the building, or any of the improvements of whatsoever nature of kinds so erected, built or situated.

SECTION 01700 - PROJECT CLOSE OUT

1.00 GENERAL: Applicable provisions of the General Documents and Specifications apply also to work under this Section.

2.00 DESCRIPTION OF REQUIREMENTS:

- A. DEFINITIONS: Project close-out is hereby defined to include general requirements near the end of Contract Time, in preparation for final acceptance, final payment, normal termination of contract, occupancy by Owner and similar actions evidencing completion of the Work. Specific requirements for individual units of work are specified in sections of Divisions 2 through 16. General requirements at time of project completion are also set forth in General Conditions and Division 1.
- B. DESCRIPTION : In anticipation of the completion of construction operations, the contractor shall, in compliance with project specification preparation, coordination, assembly and subsequent transmittal of project documents and records to the Architect for review as on of the prerequisites for certification of substantial completion and final payment.
- C. PROJECT RECORDS AND DOCUMENT REQUIRED PRIOR TO SUBSTANTIAL COMPLETION:
The required project records and documents for submittal prior to achievement of substantial completion shall include, but not necessarily be limited, to the following list of items (3 copies of each) bound in three (3), three ring binders, with the Project name, Owner's name, Architect's name, and Contractor's name.
1. Provide a list of all sub-contractors and the major suppliers of materials for the project including their business address and telephone numbers, and contract person(s) for Warranty work.
 2. Obtain and deliver to Architect, for delivery to Owner, all special tools necessary for maintenance, operation, or monitoring of equipment apparatus.
 5. Manufacturer's printed instruction manuals describing operating, servicing, maintenance and repair of each item of equipment and apparatus, including a complete description of each item with all ratings, capacities, and characteristics along with full detailed parts lists including all numbered parts of each item.
 6. Written documentation indicating that the Owner has received all of the prescribed sessions of in-service training associated with systems, materials, equipment, maintenance, and procedures.
 7. Documents required by the General and Supplementary General conditions.
 8. Include Table of Contents with tabbed, rigid dividers between sections. Three ring binders shall be white with clear plastic cover to receive front and side title information.
 9. Such warranties, Bonds, Guarantees and Certifications shall be included within separate

sections within the 3-ring binder and shall be entitled "BONDS", "CERTIFICATES", "GUARANTEES".

10. Drawings shall be reduced to an 11" high height with width folded-in.
11. Sections shall each be tabbed and entitled with rigid dividers. (e.g. "MAINTENANCE," "TEST DATA," "MANUALS," "IN-SERVICE TRAINING," ETC.)

All above information is to be transmitted to Architect at one time prior to requesting substantial completion inspection.

D. PROJECT RECORDS AND DOCUMENTS REQUIRED PRIOR TO FINAL PAYMENT

The following project records and documents for submittal prior to final payment shall include, but not necessarily be limited to, the following list of items (3 copies of each):

1. Contractor's written certification that all punch list items have been completed.
2. Certification of Contractor's affidavit of payment of debts and claims, AIA G706A.
3. Certification of Contractor's affidavit of release of Liens, AIA G706A.
4. Certificate of consent of surety company to final payment, AIA G707.
5. Documents required by the General and Supplementary General Conditions.

7. Contractor's request for final payment.
8. Resolution of all allowances.

CLEANING UP: Leave all area in clean condition; remove from site all waste material, lumber, debris, etc. Glass windows to be thoroughly cleaned and washed, replace all broken glass. Building shall be left in a condition ready for occupancy by the Owner by the date of Substantial Completion fixed in the Notice to Proceed.

E. INSPECTION PROCEDURES:

1. Prior to requesting inspection:
 - a. Each Subcontractor shall make careful inspection of their work, and shall furnish a typewritten list of incomplete items to Contractor and Architect. Said list shall be specific as to room number, and location of incomplete or unacceptable condition.
 - b. Contractor or his superintendent shall review lists furnished by subcontractors, make a careful inspection personally of all areas scheduled for Substantial Completion, assuring that the work on that part of the Project is ready for Substantial Completion, prepare and submit a separate typewritten list of incomplete items to the Architect for review, and then notify in writing, the Architect and Owner, to make their inspection.
 - c. Prior to requesting inspection: Contractor or his superintendent shall make a careful inspection personally of all areas scheduled for substantial completion, assuring himself that the work on that part of the project is ready for Substantial Completion acceptance, and then notify, in writing, the Architect and Owner to make their inspection.

2. Initial Inspection: Upon receipt of Contractor's request, Architect will either proceed with inspection or advise Contractor of prerequisites not fulfilled. Results of completed inspection will form initial punch list for final acceptance.
3. If, at the end of the 30 days granted to Contractor for completion of all items on the punch list at the time of issuance of Substantial Completion, any items have not been completed, Contractor will notify Architect, in writing, of the status of the punch list items.

3.00 CLOSE-OUT PROCEDURES

- A. GENERAL OPERATING/MAINTENANCE INSTRUCTIONS: Contractor shall arrange for each installer of work requiring continuing maintenance and/or operation service, to meet with Owner's personnel at project site to provide basic instructions as required for proper operation and maintenance of the work. Include instructions by manufacturer's representative where installers are not factory-trained experts in the required procedures. Review maintenance manuals, record documentation, tools, spare parts and replacement materials, lubricants, fuels, identification system, control sequences, hazards, cleaning and similar procedures and facilities. - (A) Provide all labor and material required to furnish and install protection padding (walls, floors, concrete bunk, doors, frames and ceilings) in holding cells C118 and C182 as indicated in drawings and specified herein
- (B) Submit typical shop drawings showing details, thickness of materials and typical requirements.
- (C) Submit three (3) samples – minimum of 3"x3" in size – for approval and acceptance of protective padding system for use in safety cells, seclusion rooms and time-out rooms.
- (D) Submit two (2) copies of the manufacturer's maintenance instructions

1.2 Guarantees

- (A) Protective Padding Contractor shall agree to repair or replace any defective material or work for a period of one (1) year from the date of project completion. This guarantee shall also include any loss of adhesion, resiliency or delaminating. This guarantee does not cover the damage caused by sharp or burning objects. Guarantee for this work shall be signed the Protective Padding Contractor

1.3 Qualifications

- (A) Because of the special nature of the work specified within this section, persons, firms or corporations desiring to bid on this section of work must meet the following requirements:
 - (1) Have a minimum of five (5) years experience in the fabrication and installation of protective padding or work similar to that which is described herein.
 - (2) Have ten (10) successful installations of protective padding in detention facilities.

PART 2 – MATERIALS AND PRODUCTS**2.1 General**

- (A) Protective padding material shall be a synthetic resinous material. Substitutions of a closed cell polyvinyl chloride or other types of polyvinyl chloride surfacing material will not be permitted. Protective padding meeting the following requirements and approved for use is Gold Medal Safety Padding as manufactured by Marathon Engineering Corporation, PO Box 310, Mountain Ranch, California 95246, (209) 754-5121, www.goldmedalsafetypadding.com
- (B) All vertical panels shall be prefabricated. The panels are to be 1" nominal thickness Gold Medal Safety Padding bonded on Oriented Strand Board 7/16" thickness, making the wall panels a total of 1-1/2" thick.
- (C) The door jambs shall be 1/2" thickness Gold Medal Safety Padding with a durometer of 60 plus or minus 5, for a total of 1" thickness on door jambs.
- (D) All floor panels shall be prefabricated. The panels are to be 3/4" Gold Medal Safety Padding bonded on Oriented Strand Board 7/16" thickness, for a nominal thickness of 1-1/4"

2.2 Properties

- (A) In addition to meeting the minimum physical properties when cured, protective padding must contain a flame spread and smoke index which when tested in accordance with ASTM E84 is given a CLASS A FIRE RATING.
- (B) Padding must also conform to the following criteria.
 - (1) Weight is approximately 5 pounds per square foot
 - (2) Tensile strength range 300 P.S.I. minimum ASTM D412
 - (3) Temperature stability – unaffected from 20 degrees F to 120 degrees F
 - (4) Moisture absorption 0.8% to 1.05% by weight
 - (5) Compression set 90% recovery after 72 hours
 - (6) Compression properties 30 PSI to 70 PSI at 50% modulus
 - (7) Elongation at break 150% typical ASTM D412
 - (8) Fungus resistance complete
- (C) Fasteners for use in security vertical panels shall be recommended by manufacturer.

PART 3 - EXECUTION

3.1 Installation of Protective Padding

- (A) Installation shall be in strict accordance with manufacturer details.
- (B) Inspect surface(s) to receive work under this section. Notify the architect in writing if surface(s) is not satisfactory for application of materials. Commencement of work constitutes acceptance of surface.
 - (1) All concrete surfaces must have a sixty-day (60) cure. No bonding agent or curing agent will be allowed.
- (C) All vertical panels will be mechanically fastened to walls
