

Ramirez, Jr., Judge of the 332nd District Court of Hidalgo County, Texas, as a representative of the Hidalgo County Juvenile Board, do hereby certify to the Commissioners' Court and the Chief Juvenile Probation Officer of Hidalgo County, Texas, that I have personally inspected the Hidalgo County Post Adjudication Secure Juvenile Boot Camp Facility in Weslaco, Texas and hereby have determined that the facility is suitable for the detention of children as provided by Section 51.12(c) of the Juvenile Justice Code. The facility will also comply with Texas Juvenile Probation Commission Standards for Juvenile Post-Adjudication Secure Correctional Facilities.

THEREFORE, the Hidalgo County Post Adjudication Secure Juvenile Boot Camp Facility is hereby Certified a suitable facility that can safely house forty (40) juveniles until the next annual onsite inspection due one year from the above personal visit. The Commissioners' Court and the Chief Juvenile Probation Officer of Hidalgo County shall be furnished copies of said certification.


