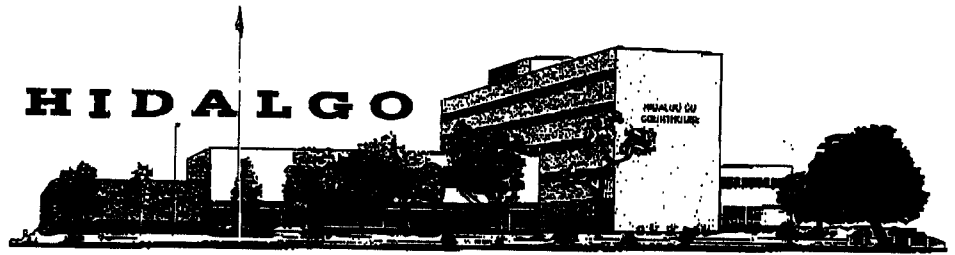
Marty, please place the following item on the agenda for the January 23rd


Dear Commissioner Flores,
