The login name and password will be maintained as part of the bondsman code within the Product Admin suite of the CCM module.</p> <p>The website will be created using ASP and/or ASP.NET scripts and XML/XSLT to format the data to the user.</p> <p>All data in this website will be live and view-only – the user will not be able to make any modifications to the data.</p>
