
Before me, the undersigned authority, personally appeared Martha Alvarado, who, being by me duly sworn deposed as follows:



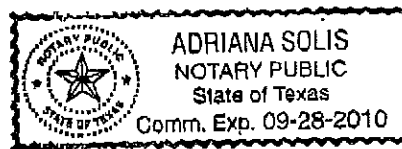
