The proposed budget and program amendment will decrease Street Improvements (Sullivan City) in the amount of \$281,701.00 and transfer funds in the amount of \$240,349.00 to Fire Station/Equipment for the purchase of fire protection unit(s). The proposed budget and program amendment will create a Flood Drainage Improvement line item in the amount of \$41,352.00 for flood drain improvements in Monica Acres.

The proposed budget and program amendment will decrease Youth Services (Palmview) in the amount of \$24,651.00 and transfer funds into the Street Improvement line item.
