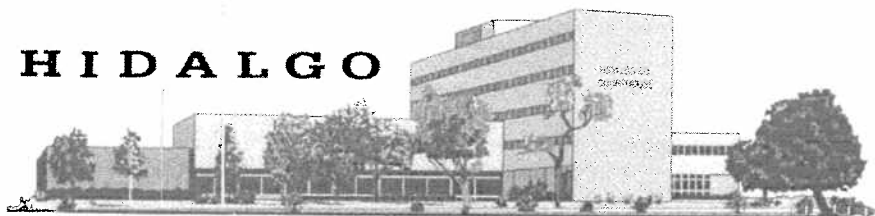

**ROAD CONSTRUCTION**

This Agreement, entered in to the \_\_\_\_ day of December, 2007 by and between Hidalgo County Precinct No. 1 (hereinafter called the "Owner," and \_\_\_\_\_. (A Texas Corporation), of County of Hidalgo, and State of Texas, hereinafter called "Contractor."

**WITNESSETH**

That for and in consideration of the payments and agreement hereinafter mentioned, to be made and performed by the OWNER, the CONTRACTOR hereby agrees with the OWNER to commence and complete the construction described as follows:

**Mile 13 1/2 (From FM1015 West to Mile 6)**  
**Mile 12 (From FM88 to Mile 6)**  
**Mile 5 (From Milano to Midway)**

Hereinafter called "the project," for the sum of

and all extra work in connection therewith, under the terms and stated in the General and Special Conditions printed or written explanatory matter thereof, the specification and contract documents therefore as prepared by RODRIGUEZ ENGINEERING, entitled the Engineer, along with the Performance and Payment Bonds hereto attached; all of which are made a part hereof and collectively evidence and constitute the entire contract.

The CONTRACTOR hereby agrees to commence work under this contract on or after a date to be specified in written "Notice to Proceed" of the OWNER and to fully complete the project within 120 working days thereafter. The CONTRACTOR further agrees to pay, as liquidated damages, the sum of \$ 250.00 for each consecutive working day thereafter.

The OWNER agrees to pay the CONTRACTOR in current funds the price of unit prices in the Bid Proposal Form which forms a part of this contract, such payments to be subject to the Special Conditions and Specifications of the Contract. Payments will be made based the amount of work completed per month.
