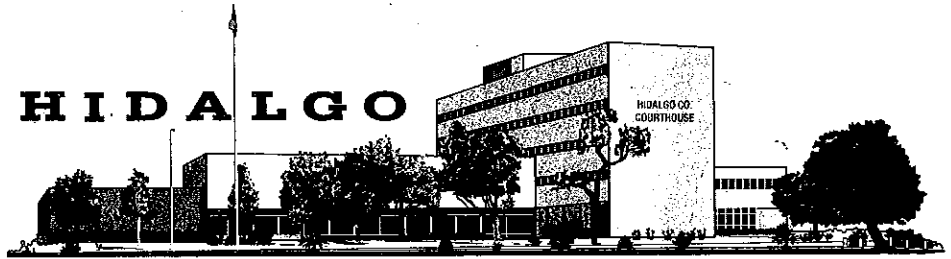

Hidalgo County Precinct 4 is requesting a budget and program amendment to its Urban County Program Year 18 funds by decreasing the "Parks, Recreational Facilities" line item by \$59,981.67 to create a "Re-hab Single Unit Residential" line item in the amount of \$40,000.00 and increase the street improvements line item by \$19,981.67.

At this time we are also requesting that Year 19 funds from "Parks, Recreational Facilities" in the amount of \$75,000.00 to be transferred into the existing street improvements line item.
