

**SPECIFICATIONS/REQUIREMENTS/INFORMATION TO BIDDER
HIDALGO COUNTY PRECINCT NO. 1
“HAULING SERVICES FOR ALL ROAD MATERIALS”
EXHIBIT “A”**

SECTION I - SPECIFICATIONS

It is intended that all hauling of road materials will be within Hidalgo County Precinct # 1 - Zone A, Zone B, and Zone C and will be awarded on a per ton basis, per mile radius. This bid price will be for the duration of one (1) year with the County's option to renew for an additional one (1) year. Hauling services will be on an “As Needed Basis” by the precinct.

1. Road materials (i.e. crushed, sand, gravel, hot mix, cold mix) will be hauled from vendor pits that are currently holding the contract for material bids. Vendors stated are presently on Contract for the materials, however, vendors may change due to contract expiration during the term of this bid. Awarded vendors will be advised. Location of pits and plants are as follows:
 - **Cold Laid** - Frontera Materials (La Joya Plant)
 - **Type D Hot Mix- Gravel** (Frontera Materials Progreso Plant)
 - **Type D Hot Mix - Limestone** (Frontera Materials Progreso Plant)
 - **Crushed Caliche** - Frontera Materials - (FM 490 Pit and/or Moorefield Pit) and Valley Caliche - Mann Pit.
2. Hidalgo County reserves the right to award the bid on a lump sum basis to one bidder or to multiple bidders if the County determines it is in its best interest to do so.
3. **Bid price for the services must be per ton basis, per mile radius on an “As Needed Basis”.**
4. Bid award will be based on the low bid per ton basis per mile radius listed on the bid page form.
5. Hidalgo County Precinct No. 1 is requesting the minimum of **Ten (10) vendor owned and/or leased hauling trucks** that will be available for this bid with a minimum of twenty-two (22) tons per load. **Please note the make, year, model and capacity of your hauling trucks on Exhibit “D”.**
6. The bidder(s) awarded the contract must furnish proof of possessing all necessary licenses, ownership (title for all owned vehicles) and permits and also provide evidence of the required insurance as outlined in Exhibit “C”. Copies of all licences, permits and insurance coverage must be submitted to the Hidalgo County Purchasing Department upon bid award.
7. The bidder(s) awarded the contract **cannot** engage the services of a **subcontractor without prior written consent of Hidalgo County** to perform services hereunder. The successful bidder(s) must

present evidence that the proposed subcontractor possess all the necessary licenses and permits to perform the services and that subcontractor has obtained the required insurance.

8. **Bidder(s) will be required to complete and submit the Supplemental Hauling Data Sheet for every driver as detailed in Exhibit "E" upon bid award.**
9. Contractual agreement is not exclusive, as Precinct #1 may use own hauling vehicles when necessary.
10. Any contract award to a successful bidder will be in effect until (a) the contract expires, (b) delivery and acceptance of products, and/or performance of services ordered, or (c) terminated by County with thirty (30) day's written notice prior to cancellation.
