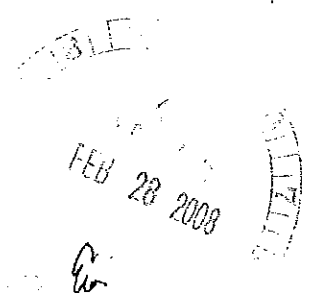

The proposed amendment to the Street Improvements line item will decrease the activity and transfer funds to Water/Sewer Improvements and General Administration.

The proposed amendment to Water/Sewer Improvements will include the upgrade improvements to four manholes located on Robert Street and Lopez Street.

The proposed amendment will create a General Administration activity for the CDBG project oversight.
