This letter is to confirm this is a certified copy of the March 18, 2008 Public Hearing Minutes for 6:00 p.m.

Agenda Item 1., [Discussion on Public Hearing Notice to Discuss and Solicit Input on Community Development Block Grant (CDBG) Requirements on City's Proposed Budget and Program Amendment to Urban County Program Year 20 (2007)] from the Public Hearing held at City Hall in Hidalgo, Texas on March 18, 2008.

Mayor Pro-Tem Samano said the agenda item was on Discussion on Public Hearing Notice to Discuss and Solicit Input on Community Development Block Grant (CDBG) Requirements on City's Proposed Budget and Program Amendment to Urban County Program Year 20 (2007). Mr. Vera said at the last meeting Council approved proceeding on advertising for Public Hearing for Urban County Budget Amendment for \$61,706.75 in Urban County fund surplus money that had been set aside for water and sewer plant and was left over from that project. There was one interest payment of \$7,683.25 due in August. Additionally, to leave the \$7,683.25 line item and move \$54,023.50 to use for swimming pool improvements and take additional money needed from general fund to complete the improvements.

Mayor Pro-Tem Samano asked if there were any comments from the public. There were none. Councilmember Franz asked if the balance was paid off for the current year on the sewer project and verified there were two more years. Mr. Vera said yes, there were two more years. There was no further discussion.
