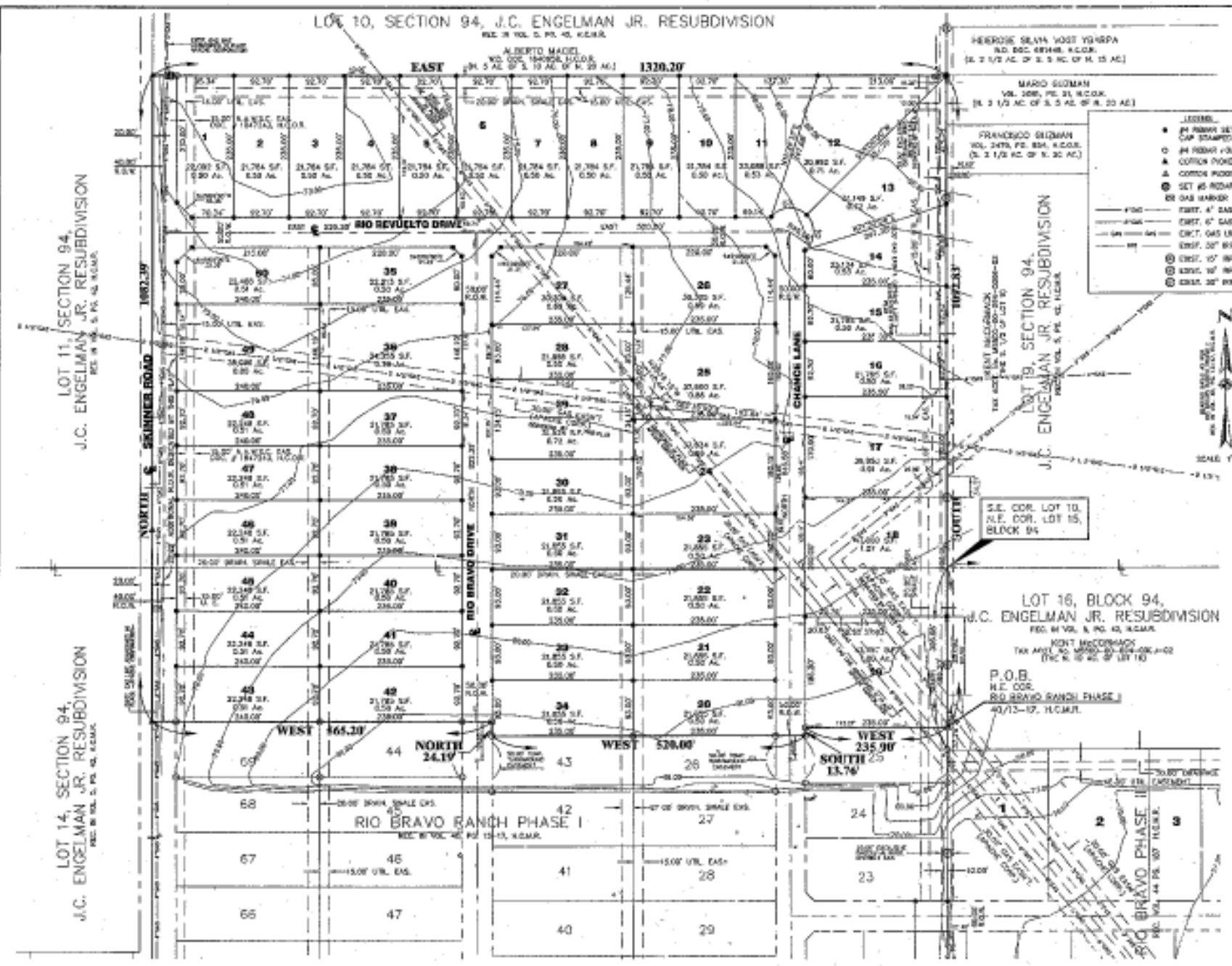


LOT 10, SECTION 94, J.C. ENGELMAN JR. RESUBDIVISION
