On February 26, 2008, Commissioner's Court approved RFP #2008-063-03-19—OGG. Proposals submitted by Willie's Appliance and Furniture and Sears Commercial were provided to us on March 25, 2008. On April 4, we submitted, to the Purchasing Department, the results, our recommendation including scoring sheets for each proposer and the name of individuals evaluating the proposals for Commissioner's Court review and approval. On April 16, 2008, we are asked to submit clarification of the results.

Please be advised that the RFP #2008-06303-19—OGG was structured to eliminate subjectivity. You will notice that on Attachment B-Integrity and Financial Resources on item I-Integrity-the questions that the references listed would be asked require a yes or no response. On Item II-Financial Resources-the questions listed require a yes or no response from the proposer. On Attachment B-1-Technical Knowledge and Experience on Item I-Technical Knowledge questions 2-4 that the references listed would be asked require a yes or no response. On question 1, a favorable response would be scored. On Item II-Length of Experience-scoring was based on the number years of experience. On Item III-a yes or no response was required from the proposer. Each attachment had clear instructions on the value of each question, how points would be awarded, and the maximum points that may be received.
