After reviewing the contract between Hidalgo County and Anda, Inc., we noticed that the contract has an additional one year option to extend and renew, under the same rates, terms and conditions. We also received a letter from Anda, Inc. regarding their willingness to renew the current contract for the additional year and also offering us the product at a lower (discounted) price per case of \$78.40 (current bid price of \$92.40).

It is my understanding that after discussing the situation with Marty, you still feel that we can get better pricing by going out for bids.

I have researched the previous bid and it clearly shows that the other participating (all local) vendors that submitted bids were still higher than the current price.

Given all of the ongoing communication, the time frame to proceed to advertise, receive, tabulate and award, the bid has been considerably shortened. Thus, we find it necessary to recommend to Commissioner's Court for their consideration and action to exercise a 60-day extension at the current price, so as to have no lapse in service while the procurement process is completed.
