Attached please find information regarding the award of the above-referenced 2nd Call Colonias Project for road construction and drainage.

Please be advised that the County will proceed to award the bid based on the following:

- 1). Engineers Recommendation
- 2). Bidder meets all County requirements
- 3). Bid is the lowest of bids received
- 4). Cost Breakdown

R. Gutierrez Engineering, Inc. has reviewed bids and tabulations and is recommending Sascon, Inc. as the low bidder for the above-referenced project. The amount budgeted for this project is \$116,782.40 for road construction and \$28,619.59 for drainage work for a grand total of \$145,401.99. Bid award is for drainage only (curb and gutter, driveways, etc.). County force account will install the storm drainage including RCP and inlets. Funds will be transferred from roadwork into the drainage line item within this account. Roadwork will be done by county force account.

The award will be to the low bidder Sascon, Inc. for the bid in the amount of \$56,552.00. The bids received were as follows:


- Sascon, Inc. \$56,552.00
