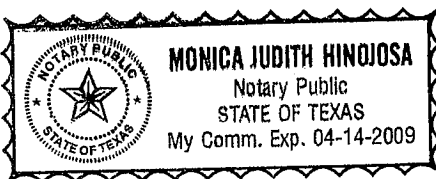
1. My participation in the association or organizations is for the betterment of County Government and the benefit of me as a County Official or employee;
