We are pleased to forward to you the Border Security Equipment and Technology (BSET) Grant Guidance and Application Kit. The BSET is a one-time grant opportunity and applications will be accepted for consideration on a "first come, first served" basis. Because funds are limited, not all requests may receive funding.

In addition to the application package, there are copies of the forms that must be filled out to apply for this grant attached to this e-mail.

1. This grant will facilitate the acquisition and deployment of law enforcement technology as a means to help law enforcement agencies secure the border and counter border centric crime. Equipment and technology acquisitions must benefit border security operations and Operation Border Star. This grant will be funded by the portion of State border security appropriations that is for that specific purpose.
2. The BSET is a reimbursement program of actual costs for eligible purchases. Advances may be provided to supply sufficient funds to the participant to acquire eligible equipment and services during the specified period.
3. The project period begins on May 1, 2008 and ends on August 31, 2009. All funds must be expended by August 31, 2009. Given the statutory deadline for the program, no extensions can be granted for this BSET Grant Program.
