
Dear Valde,

As you are aware, the State made some funds available for repairs to buildings which are being used to house our residential programs. In our case, this applied to the Boot Camp Complex and the Restitution Center building which are both owned by the County of Hidalgo.

I made a decision to apply these State funds and repair/replace all air conditioning units in both buildings. A walk-thru was conducted and proposals were submitted by Johnson Controls, Inc. The proposal for the Boot Camp totaled \$94,572.20. We had \$70,000.00 State dollars for that project. As you can see we were approximately \$25,000.00 short.

At this time, I am requesting that the County contribute the \$25,000.00 needed to complete the project. This would result in having completely new air conditioning equipment at the Boot Camp Complex which will reduce repair costs for the next several years.
