RE: Replacement of Wrecked 2008 Ford Pick-Up Truck

On July 7, 2008 a deputy operating a new 2008 Ford F-150 was struck by a drunk driver causing extensive damage to our unit that included a bend frame.

On August 12, 2008 an adjuster from the other driver's insurance came by to do an estimate on our vehicle. We were later informed by Mr. Roy Quintahilla from DBM Safety Division that the insurance adjustor determined that the loss to our vehicle exceeded their policy's maximum allowance, and therefore were only offering to compensate the County their maximum limit of \$15,000.00. We have also now been informed that the Insurance Company has settled with Risk Management and that they have already submitted their payment of \$15,000.00 to Risk Management.

The Sheriff was consulted about his option of repairing the unit and hoping that the bend frame would not be major factor. The Sheriff advised that he would rather use the whole amount of \$15,000.00 plus utilize funds from his forfeiture account and buy a new vehicle. We are therefore making a request to the Budget Office to set up a special account from the proceeds received from the settlement so that the Sheriff's Office can access the account for the purchase of a replacement vehicle. We are inclosing for your information a quote from Philpott Motors under the BuyBoard contract. The reason for a 2009 model we were inform is that Ford has stopped producing the 2008 models and are now gearing up for the 2009 models. Please advise us as soon as the account has been created so that we can proceed from there.
