Chief,

On Monday, February 25, 2008, Asst. Chief Javier Gonzalez and I met with ICE Special Agent William David Baer, Jr. at the Police Department to discuss a grant awarded to ICE for the purpose of domestic highway enforcement. Agent Baer explained that we would select 2-4 officers that would be assigned to work over time. During their work shift the assignment would be to concentrate efforts on drug interdiction. ICE was awarded \$27,000 that will be shared with Mission P.D. The departments will be reimbursed for at the over time rate for the hours worked. Ray Tovas will work as a liaison in this program. I am assigning Lt. Robles to prepare and submit monthly invoices to ICE Agent Baer for reimbursement. The four officers selected will be randomly assigned. They have all demonstrated an interest and more importantly an ability to work drug interdiction. I believe these officers to be able and be the most productive. An end of program report will be compiled for future assessments.

**INTERLOCAL GOVERNMENTAL AGREEMENT
HIDALGO COUNTY HIDTA TASK FORCE
AND
UNITED STATES IMMIGRATION AND CUSTOMS ENFORCEMENT, (McALLEN)**

This Agreement is entered into by the **HIDALGO COUNTY HIDTA TASK FORCE** hereinafter referred to as "HIDTA" and the **UNITED STATES IMMIGRATION AND CUSTOMS ENFORCEMENT**, Special Agent in Charge, McAllen, Texas hereinafter referred to as "ICE" for the purpose of the reimbursement of costs incurred by ICE in providing resources to joint operations/task forces.

The Executive Office of the President, Office of National Drug Control Policy Office of National Drug Control Policy, awarded HIDTA \$27,200.00 of discretionary funds to satisfy the request(s) for the reimbursement of overtime and other law enforcement expenses incurred by ICE.

I. LIFE OF THIS AGREEMENT

This Agreement becomes effective on the date it is signed by both parties. It remains in force unless explicitly terminated, in writing, by either party.

II. AUTHORITY

This Agreement is established pursuant to the Grant Agreement between the County of Hidalgo and the Executive Office of the President, Office of National Drug Control Policy, Award Number 17PSSP573Z.

III. PURPOSE OF THIS AGREEMENT

This Agreement establishes the responsibilities of both parties and the procedures for the reimbursement of overtime.

IV. APPLICABILITY OF THIS AGREEMENT

This agreement is valid for all joint investigations led by ICE, McAllen under the Domestic Highway Enforcement (DHE) and other interdiction requests and until terminated, in writing, by either party.

V. TERMS, CONDITIONS, AND PROCEDURES

A. Submission of Requests for Reimbursement (Invoices) and Supporting Documentation

1. ICE may request the reimbursement of overtime salary expenses directly related to work the Domestic Highway Enforcement and other interdiction requests, performed by its officer(s) assigned to this operation up to maximum amount of \$27,200.00.
2. As part of this Agreement, ICE shall provide HIDTA with the names, titles, four last digits of SSN's, badge or ID numbers, and hourly overtime wages of officer(s) assigned to the operation.
3. ICE may not request the reimbursement of the same expenses from any other Federal law enforcement agencies that may also be participating in the investigation.

VI. PROGRAM AUDIT


This Agreement and its provisions are subject to audits conducted pursuant of OMB Circular A-133, "Audits of State of Local Governments".

VII. REVISIONS

The terms of this Agreement may be amended upon the written approval by both parties. The revision becomes effective on the date of approval.
