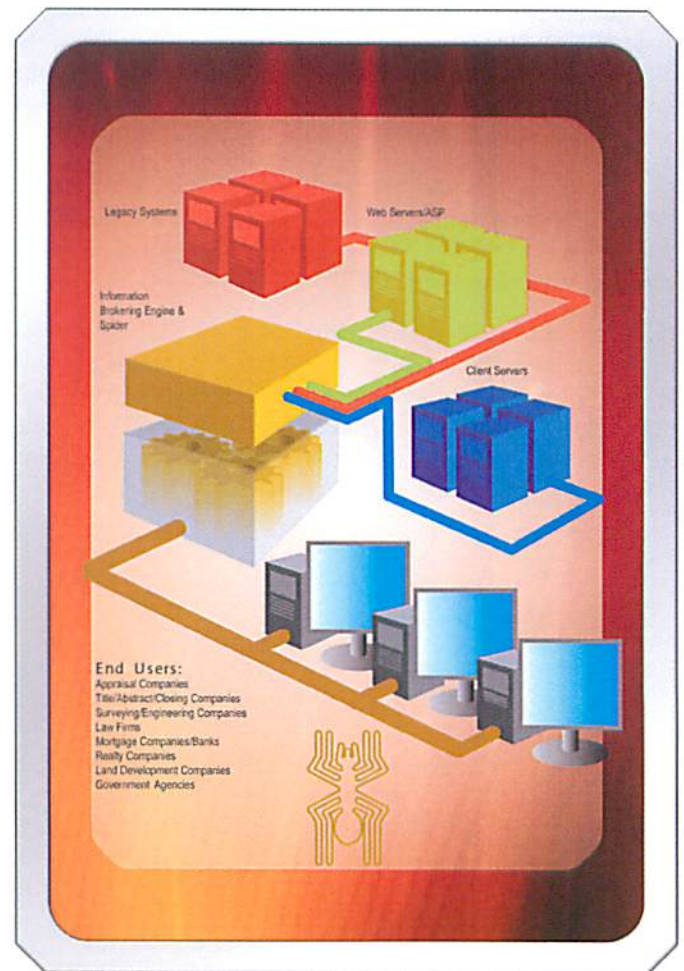
From a data-management perspective, property records are often stored in county legacy systems. The IT infrastructure of these systems are usually antiquated and it is cost prohibitive to rebuild them.

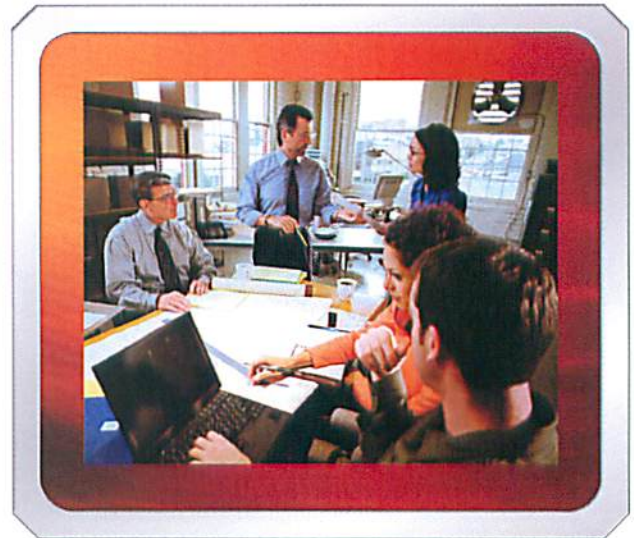
