**THIS SUPPLEMENTAL AGREEMENT** is made pursuant to the terms and conditions of Article 8 of the Agreement made by and between **HIDALGO COUNTY**, acting herein by and through the **Commissioner's Court**, hereinafter called the "**Owner**", and **Javier Hinojosa Engineering, Professional Engineers of McAllen, Texas**, hereinafter called the "**Engineer**".

**WITNESSETH**

**WHEREAS**, the **Owner** and the **Engineer** executed the Agreement on the 28th day of October, 2008 concerning engineering for Preliminary, Design and Construction Phase Services for the Texas Department of Transportation Border Colonia Access Funded Colonias for Hidalgo County Precinct Number 3 (hereinafter referred to as the "**Project**"); and,

**WHEREAS**, Part 2 of the Agreement, (Estimated Cost), establishes that the fee for the services is \$311,547.37; and, Attachment "A" establishes the projects to be designed,

**WHEREAS**, it has become necessary to amend the Agreement to substitute population allocation projects with competitive projects not awarded.

**A.    AGREEMENT**

**NOW THEREFORE**, premises considered, the **Owner** and the **Engineer** agree that said Agreement is amended as follows:

- I.    Part 2 of the Agreement, (Estimated Cost) is revised to \$311,597.20.
- II.   Attachment "A" (Listing of Colonias) is revised and made a part of this agreement as attached.

**All other provisions are unchanged and remain in full force and effect.**
