

## MEMORANDUM

**TO:** County Voter Registrar/Election Administrator

**FROM:** Dan Glotzer, Manager, Election Funds Management

**DATE:** December 17, 2008

**RE:** Renewal of 4511 Permit and Postal Accounting Fee

Before the end of each calendar year, the Secretary of State renews Business Reply Permit No. 4511 with the United States Postal Service. A BRM permit holder (SOS) can allow its authorized representatives or agents to use that permit number to receive BRM at any post office. The original permit holder must supply the representative with a letter authorizing the use of the BRM permit and a copy of the USPS receipt showing the annual fee payment for that permit.

By way of this memo along with the copy of the renewal of permit 4511, you are authorized to use this permit number to receive voter registration applications at your local post office. You must deliver a copy this memo and a copy of the attached receipt for this permit to your local US Postmaster before December 31, 2008.

In addition, our office has estimated that your county will receive more than 883 applications by mail in the next calendar year. Accordingly, a \$565 accounting fee has also been enclosed so that your county will receive a reduced per piece rate. This check must be delivered to your US Postmaster prior to December 31, 2008 to renew your BRM annual account maintenance fee.
