**WORK AUTHORIZATION NO. 1**  
**SUPPLEMENTAL AGREEMENT NO. 1**

**THIS SUPPLEMENTAL AGREEMENT** is made pursuant to the terms and conditions of Article 8 of the **Agreement** made by and between **HIDALGO COUNTY**, acting herein by and through the **Commissioner's Court**, hereinafter called the "**Owner**", and **TEDSI INFRASTRUCTURE GROUP**, professional engineers of Mission, Texas, hereinafter called the "**Engineer**".

**PART 1. Scope of Work.** The purpose of this Work Authorization is to provide services for Round III of the Hidalgo County Colonias. The existing scope will be reduced to remove Indian Hills Subdivision, CSJ No. 3C1080932. The schedule for completing the work, Attachment C will be voided and replaced with Attachment C1. This revised schedule is to reflect the notice to proceed being issued on January 16, 2009 and removal of CSJ No. 3C1080932.


**PART 2. Estimated Cost.** The lump sum amount for professional services under Work Authorization No. 1 is **\$290,304.40** as approved under Agreement No. C-CAP-08-028-10-28. This amount will be reduced under Supplemental Agreement No. 1 to Work Authorization No. 1 by **\$100,890.90** to remove work associated with Indian Hills Subdivision, CSJ No. 3C1080932. The new amount payable under Agreement C-CAP-08-028-10-28 is **\$189,413.50** and indicated in Hidalgo County Purchase Order No. 615985.

**PART 3. Payment.** Compensation and payment to the **Engineer** for the services established under this Work Authorization shall be made in accordance with Articles 5, 6, and 7 of the **Agreement**.

**PART 4. Period of Service.** This Work Authorization shall become effective on the date of final acceptance of the parties hereto.

**PART 5. Responsibilities and Obligations.** This Work Authorization does not waive the parties' responsibilities and obligations provided under the **Agreement**.
