We are pleased to have recently received notification from Leticia H. Saenz, CPPB, that Hidalgo County wishes to renew the *Contract for Services* which the County has with *LCS Corrections Services, Inc.* for the housing of County inmates in the *LCS* facility in Hidalgo County.

We agree that it would be in everyone's best interest for County to exercise its right to renew the contract for an additional one (1) year term. Due to increased costs, we would like to propose that the renewal be at an increased per diem rate, as set forth in \$4.03, of Forty-two dollars (\$42.00). We believe that such an increase is reasonable based on our operating costs, as set forth in \$1.02 of the contract. All other terms and conditions of the contract shall remain unchanged.

The contract permits the County to extend the current term by written notice of such intent. This letter is to advise that we will agree to such renewal.
