All forms of compensation (including overtime) to employees of Hidalgo County incur fringe benefits (Health and Life Insurance, FICA, Retirement, Unemployment Compensation, and Workers' Compensation). The letter addressed to Mr. Will R. Glasby (dated April 06, 2009) does not include any mention of fringe benefits attributed to the overtime hours.
