Hidalgo County Pct. #1 has purchased two playground systems, three bay swings, timbers, fiber and geofabric to be installed at the Sunrise/Sunset Park as part of the 2008 Parks, Recreational Facilities Project. Attached is the quote provided by the PlayWell Group.

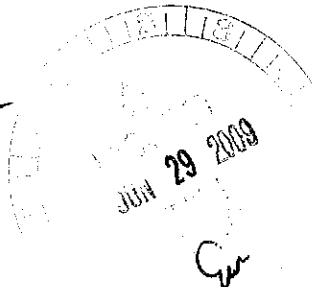
