The funding will allow for a water line extension to service homes in the city of La Villa with first time water services. There will be no budget change, only inclusion of new project.

The Precinct has requested that the funds be **ALLOCATED** to the Parks, Recreational Facility Improvements to the Sunset/Sunrise Hill park for the continuation of rehabilitation. The precinct has requested that in addition to the already approved items, they would like to add lighting to include but not limited to the purchase and installation of lights throughout the park facilities.
